Re: Time Warner Cable/ Comcast Corporation Transaction

Dear Ms. Yamamoto and Messrs. Caliboso and Kang:

By the August 2014 Agreement Regarding Application Review Period, the Department of Commerce and Consumer Affairs ("DCCA") and Applicants Comcast Corporation and Time Warner Cable Inc. ("**Applicants**") agreed that the review period for the Application ends on September 19, 2014, unless extended by mutual agreement.

Last week, DCCA and Applicants engaged in discussions regarding the transfer of control of Oceanic Time Warner Cable LLC's ("**OTWC**") Hawai'i cable franchises to Comcast. While DCCA and Applicants reached fundamental agreement on many of the points at issue, several issues remained outstanding, and Applicants agreed to provide DCCA further information and to follow up with further discussion, if necessary. As of today, receipt of the information by DCCA is still pending.

In addition DCCA is currently preparing a decision and order regarding the transaction; however, DCCA anticipates that the drafting and review of the decision and order will not be completed by September 19, 2014 and more time will be needed to complete the document. Accordingly, DCCA is requesting that the review period be

extended, without prejudice to the existing position of either party, until September 30, 2014, to afford DCCA additional time to complete its review of the Application and issue its decision on the matter.
