Dear Messrs. Caliboso and Kang:

By letter dated September 10, 2014, the Department of Commerce and Consumer Affairs ("DCCA") and Applicants Comcast Corporation and Time Warner Cable Inc. ("**Applicants**") agreed that the review period for the Application ends on September 30, 2014, unless extended by mutual agreement.

In the interim, DCCA and Applicants have engaged in discussions regarding the transfer of control of Oceanic Time Warner Cable LLC's ("**OTWC**") Hawai'i cable franchises to Comcast. While DCCA and Applicants have reached agreement on many issues, DCCA and Applicants continue to discuss the remaining outstanding matters.


On September 29, 2014, Comcast requested that the review period be extended to Wednesday, October 8, 2014, to afford DCCA and Applicants additional time for further discussion and for DCCA to issue its decision on the transaction. DCCA did not object to Comcast's request for a further extension.
