Hawaii Nursing Discussion of Pass Rate: 90% of NPR vs. No Percentage of NPR

Programs:

The Chair led the discussion of pass rate: 90% vs. no percentage of NPR. The Chair asked where in the laws and rules it says this.

The EO stated it doesn't say it anywhere in the laws and rules. The Committee had previously agreed on it and therefore it is on your annual report form.

The Chair stated that the question is if we should stay with a 90% pass rate or change it to no percentage of NPR.

The EO asked if you want a percentage or do you want to go with the national average?

Dr. Fleming stated if there is a national average pass rate, why we would say Hawaii can be 10% less than the national pass rate.

The EO stated if we change it to no percentage of NPR, that will really affect the first time takers pass rate.

The Chair stated she would like to establish some kind of support for the schools that have less than 90% pass rate.

Dr. Fleming stated she spoke with an educator from the Nevada Board of Nursing and Nevada had a very poor pass rate but in 2 years turned it around and are now number 2 in the nation's pass rate. What they did was they had a meeting with NCLEX to talk about the testing. They went to each school and discovered the faculty was unprepared to do test questions. What the faculty was doing is focusing on testing knowledge, when they should have been focusing on testing analysis and complications. They did a whole education plan for the faculty to teach them how to re-do their test so they can help students not just know information but how to apply information. Then they helped the schools re-do their curriculum.

The EO asked if it cost the Nevada Board anything.

Dr. Fleming stated yes, but Nevada has paid educators to help the Board.

The EO stated we should wait to make any changes to the pass rate requirement.

Dr. Fleming stated the Board's charge is to safeguard the people of Hawaii as it relates to nursing care providers. So if we can't assure that the nurses who graduate from our programs are competent to care for them, then that's our business.
