Call to Order: The Chair called the meeting to order at 9:40 a.m. at which time quorum was established. The Board welcomed its newest member Katharyn Daub and asked her to say a few words about herself.

Ms. Daub stated she is from the Big Island and is the Director of the School of Nursing at UH Hilo. She was on the Nursing Board previously for 6 years and has been a nurse for 30 years, and with UH Hilo for 15 years. Ms. Daub stated she is very happy to be on the Board again.

The Chair excused Mr. Hoban, Mr. Joslyn and Ms. Kodama from today's meeting.

Approval of the Minutes: The Chair called for a motion in regards to the minutes of the August 7, 2014 meeting.

Upon a motion by the Vice Chair, seconded by Ms. Daub, it was voted on and unanimously carried to approve the minutes of the August 7, 2014 meeting as circulated.

Chair's Report:

The Chair reported on her attendance at the NCSBN 2014 Annual Meeting in Chicago, Illinois, August 13-15, 2014. She stated the meeting was well attended and very informative. There were many relevant items discussed, including the compact for Registered Nurses; which have put the compact for the Licensed Practical Nurse on the back burner, and distance learning programs and standards. Also presented were the results on the study of simulation. The results showed that up to 50% simulation had no effect on NCLEX pass rates or on performance during the first 6 months of employment. However, the principal investigators made it very clear that there were certain limitations to the study; the most significant being the schools were not randomly selected, they were specifically selected. There were 7 schools selected and all had NCLEX pass rates over 90%. The second limitation was that they used Hannibal Jeffries model of simulation. They had specialized training for all the faculty and reviewers, and the recommendation was if Boards are going to use the results of this and allow for simulation, they should make it very clear that they should only use the model if they have a high pass rate or if they are using this model of simulation.

Vice Chair's Report:

The Vice Chair reported on her attendance at the NCSBN 2014 Annual Meeting in Chicago, Illinois, August 13-15, 2014. The Vice Chair attended a meeting on Regulations and discovered that there is no requirement for hospitals and other medical facilities to report nurses who are terminated or asked to resign due to medication errors. There is a book called "The Good Nurse" that was discussed at the meeting. It is a true story of a nurse who killed numerous patients and was never reported, and just moved on from hospital to hospital. There are 49 jurisdictions, and there were 48 represented at the meeting.

There is a podcast of the meeting on NCSBN's website if anyone wants to watch.

Recommendations from the Institute of Medicine, Forwarded by Wendy
Seutsugu**

The EO reported that she had a meeting with Wendy Seutsugu, Sandra LeVasseur and Celia Suzuki, PVL's Licensing Administrator. The HSCFN wants to prepare for the 2015 renewals and asked if PVL could make the survey more accessible. There are a few additional questions that HSCFN wants to add to the survey regarding APRNs. The EO asked if they could put them in informational form and state the reasons why they want to add these questions so it can be presented to the Board for review.

The Chair asked if based on the Memorandum of Understanding (MOU), do we have to give the HSCFN specific information on the applicants'.

The EO stated if the HSCFN asked for a roster of all the nurses, we will give it to them based on the MOU.

The Chair clarified, so we don't need to get the nurses' permission to give them that information.

The EO stated no, we won't be asking them for permission, but we'll be informing them that their information can go the HSCFN.

Executive Officer's
Report:

Conferences/Seminars/Meetings

NCSBN 2014 Annual Meeting, Chicago, Illinois, August 13-15, 2015 – Loraine Fleming, Glenda Tali and the EO – Report on Attendance

The EO reported on her attendance at the NCSBN 2014 Annual Meeting. One of the meetings she attended was the Nurse Licensure Compact Administrators Annual Meeting (NLCA). There are currently 24 states in the compact. At this meeting the compact states reviewed revisions to the NLCA agreement that includes qualifications for nurses and requirements of the compact state. The EO and the Chair spoke with a representative from North Carolina about their continued competency program, which the HSCFN introduces legislation this past year that mirrors their program, but she did not have any follow-up information.

The EO stated she has the “Journal of Nursing Book”, if anyone wants a copy.

Another interesting piece was a study done by Washington State. This study asked, “Does governance structure of the board of nursing influence regulatory performance outcomes”? Three boards of nursing were reviewed, Washington State, an umbrella structure, Arizona, semi-autonomous board structure, and North Carolina, independent board structure. In conclusion, although the boards had a common goal, more autonomy over the performance outcomes, improved its performance in licensing, discipline, personnel, and financial outcomes. The Chair, Vice Chair, and EO then attended the CGFNS reception. CGFNS is the only credentialing organization that is approved by the Board to evaluate the education of nurse applicants who are foreign educated. .

2014 NCLEX Conference, Charlotte, North Carolina, September 29, 2014

The EO reported that Ms. Tali will be attending the 2014 NCLEX Conference in Charlotte, North Carolina, September 29, 2014.

2014 International Nurse Regulator Collaborative Symposium Chicago, Illinois, October 28-30, 2014

The EO reported the 2014 International Nurse Regulator Collaborative Symposium will be held October 28-30, 2014 in Chicago, Illinois and asked if anyone is interested in attending.

2014 Legislature – Deadline for Administrative Bills – September

The EO reported during her meeting with the HSCFN, she asked them if they will be submitting legislation for the 2015 session. Wendy Seutsugu, Executive Director of HSCFN did not know at this time if they will be submitting legislation for the 2015 session.

The EO stated DCCA’s Licensing Administrator is saying if it is important that you submit a bill they will look at it, but you must submit it by September 10, 2014.

The Chair asked if we could put mandatory reporting in the rules, or would that require legislation?

The DAG stated that would require legislation.

The EO stated we could put it in the rules under "Unprofessional Conduct". If someone fails to report a nurse doing something unprofessional or a possible violation of the laws and rules that would be unprofessional conduct.

The Chair stated this failure to report is not unprofessional conduct. She means to say if a nurse is suspected of doing something that is related to their clinical practice, many organizations give them an opportunity to resign and don't report. Then this person goes somewhere else and possibly does the same thing. What the Chair is suggesting is if a nurse is terminated or asked to resign due to a possible violation, it needs to be reported.

The DAG asked report it to whom?

The Chair stated, report it to the Board. What some states do is if your employment is affected based on a practice issue; it's reported to their board.

Information about the Regulated Industries Complaints Office (RICO) and what they do was provided to the Board members.

Correspondence

Medication Administration – Delegation – Deferred from July 10 and August 7, 2014 Meetings

Ms. Joan Takamori was present and addressed the Board. Ms. Takamori stated she is asking for consultation from the Board on looking at safe practices for scope of services under the Dept. of Education (DOE). To give some background, up until 2007 Dept. of Health (DOH) provided school health services for DOE, however in 2007 it was moved over and split. Nurses stayed with DOH and the health aides went over to DOE. Prior to 2007, DOH had the responsibility of overseeing the health aides and delegating medication administration to them, and provided support on a regular basis because everyone was under DOH. Now that the health aides are with DOE, DOH has to negotiate with them as far as the time that DOH can work with the health aides. The issue now is all 255 DOE schools have a public health nurse that is assigned to oversee approximately 3-5 schools per nurse. Based on a Memorandum of Understanding (MOU) that DOH has with DOE, the nurses provide consultation to the DOE. Up until now the DOH provided the recommendations for medication administration, but we cannot say that we're delegating because administratively the health aides now come under the principals of the school. Basically, based on the superintendent's direction, the health aides are to follow our recommendations. One of the things Ms. Takamori is asking for as far as consultation of the Board is the language in their documents, to support how they are providing the safe practices in the school setting. Under DOE's law it says that the DOH will approve medications. The concern about this wording is that someone may think that DOH is delegating. Since 2007, the DOH has provided a health aide manual to them that is reviewed annually. Annually they meet with all 255 health aides and go over the manual and medication administration. However, there are a few health aides that are concerned with the language in the manual, and want it changed to say approve instead

of recommend. What Ms. Takamori is concerned with changing the language to "approve" is what it could make someone think of when they see the word "approve". In the MOU and in DOE's policy and in the manual, they have always used the word "recommend". It is up to the administrator, which is the principal that will direct the health aide.

The Chair stated in your MOU you can still give yourself the authority to delegate even if you are two different divisions. Delegating does not mean they have to work for you, it just means they have to report their practice to you.

Ms. Takamori stated her only concern with that is because they are under two different departments; she would have to be very careful about using the word delegate in an MOU, because administratively they come under DOE.

The Chair stated delegation in the context of clinical care is not administrative. They can report to a different boss for their time, attendance and discipline, but they would be reporting to the nurse for the clinical part of it.

Ms. Takamori asked, so we do have the ability to delegate across departments?

The EO stated it's not relevant whether you work in the same department. If you are responsible for those 3-5 schools and those health aides, then you are delegating to them in the terms of your nurse practice. If your concern is you cannot properly supervise and train them, then that is an issue you need to take up with the DOE.

The Chair stated if you have a public health nurse assigned to a school, whether you call it delegation or recommendation, if the health aide does something bad, that public health nurse will be called into question because they are still the professional responsible. So it would be strongly encouraged to work with the DOE to accomplish what is necessary for the nurse and the health aide to do their job well.

The DAG stated the Board today is only opining on the delegation in its rules §16-89.2, and is not going to contradict or intervene in DOH's or DOE's structure and policy.

Another thing that Ms. Takamori found out is in 2007, the branch chief at DOH at the time, Ruth Ota had requested consultation from the Board. Ms. Takamori is requesting to see the minutes from that meeting.

The EO stated she will look for those minutes and provide a copy to Ms. Takamori. The EO is putting together a delegation packet, based on another inquiry, and will provide a copy to Ms. Takamori once that is complete.

The DAG asked Ms. Takamori, going back a few paces, why this MOU was drafted with the slant of recommendation and consultation versus delegation.

Ms. Takamori stated when the school health aides moved over in 2007, we were told by our administrators in public health nursing branch that we could no longer delegate and we never questioned it.

The Chair stated it sounds like they are confusing delegation with direct reporting, and that has nothing to do with it.

Ms. Takamori thanked the Board for their time and stated she will be following up with her advisors within the DOH.

APRN Scope of Practice – Non-prescriptive Authority vs. Prescriptive Authority

The Board reviewed an email regarding interpretation of statutes and rules governing practice of APRNs.

The EO stated she looked at the sections pertaining to APRNs and APRNs with prescriptive authority and does not see conflict.

The DAG stated she does not see any conflict either and addressed the members of the Board for their opinion. The Board agreed that they do not see conflict.

It was the consensus of the Board that they do not see any conflict of interpretation between HRS §457-8 and HAR §16-89-81.

Inquiry from Hawaii Licensed APRN (Family NP) Regarding Prescribing Medical Marijuana

The Board reviewed an email inquiry asking what the process is or who the point of contact is to become licensed in Hawaii to prescribe medical marijuana.

The EO stated under the Exclusionary Formulary, which is attached at the end of the Hawaii Administrative Rules Chapter 89, it list what APRNs with prescriptive authority cannot prescribe. The last one on the list is medical marijuana as restricted in Hawaii Revised Statutes §329-121. The statute is very specific that only a licensed physician can prescribe medical marijuana.

The inquiry will be referred to the Department of Public Safety, Narcotics Enforcement Division.

Executive Session:
