Call to Order: The Chair called the meeting to order at 8:32 a.m. at which time quorum was established.

Vice Chair's Report:

The Vice Chair asked her students from University of Phoenix, Nursing School who were in the audience today to introduce themselves.

# Hawaii State Center for Nursing:

## **Proposed Bill Relating to Continuing Competency for Nurses**

Wendy Suetsugu from the Hawaii State Center for Nursing (Center) was present and addressed the Board regarding the Center's Continued Competency bill that they would like to present to the legislature for 2015. Ms. Suetsugu stated she wants to meet with all interested parties which is why she is here today. She already met with Senator Baker, and will be meeting with Senator Green after the elections; she has spoken with Joan Craft at HNA and has contacted HGEA to set up a meeting. Dr. Sandra LeVasseur will be the acting director when Ms. Suetsugu goes out on maternity leave but Dean Boland will be handling the legislative stuff. The bill being introduced this year has been

simplified from what was introduced last year. For example the self-assessment piece has been removed.

The Chair asked if the self-assessment piece has been removed, how is it a continued competency bill and not a continuing education bill?

Ms. Suetsugu stated that they added other ways that you can get credit. On page 5, under **Learning activity options**, they added the following four sections:

- Completion of a nursing research or evidence-based practice project as principal or co-principal investigator;
- Authoring or coauthoring a peer reviewed published nursing or health-related article, paper, book, or book chapter;
- Developing and conduction a nursing education presentation or presentations totaling a minimum of five contact hours; or
- Completion of a board-recognized nurse residency program.

The Chair stated essentially it is what you would need for certification.

Ms. Suetsugu stated on page 6 under, **Authorized providers of continuing competence units**, that section is also new and it states:

 Continuing competency may be taken in a conventional classroom setting, via online courses, professional journals, correspondence, or other emerging venues recognized.

The Chair stated on page 8, it states <u>including a false attestation of compliance with the continuing competency requirements</u>, so is it correct that the Board will not be requesting for proof of attendance, or completion.

Ms. Suetsugu stated yes, only if the Board decides to audit.

The EO stated the Board will work on that section because it was a little confusing. Right now it says If they want an extension, they would have to come to the Board, the Board would say yes or no and if they don't do it within that 2 year period, the license is renewed on inactive status. It just needs to be cleaned up a bit so that it is very clear that there is a deadline, but if you ask for an extension, your license will be renewed on inactive status until you can provide proof to the Board that you completed the requirement. I believe that was the intent of the language.

The Chair asked if the standards are the same for RNs as well as LPNs.

Ms. Suetsugu stated yes. The only difference is the credit hours required.

The DAG offered a suggestion for the Board to consider based on what another healthcare board does, in that instead of renewing the license on inactive status, the licensee would just have to make up what they did not do in the prior biennium, so you would do double in the current biennium and that way there would be no break in their active status.

The Chair asked what if they don't do it in the second biennium either.

The DAG stated then they would lose their license. However, she does not know of this ever occurring with the other board.

The EO stated that they would be allowed to practice, and if they lose their license they have already been practicing all that time. It's a continuing competency issue.

The DAG stated it is just a suggestion for the Board to consider.

The EO stated there are a lot of Board recognized national c certifying bodies and programs, the Board would have to come up with a list of those organizations that you would recognize. The EO stated there are few other minor areas that she wants to clarify. On page 3, line 11, right now it states Upon application for license renewal or reinstatement, restoration and reactivation should be included as well. Then continuing onto line 12, it states each licensee shall sign the attestation on the renewal application as to the licensee's successful completion, I'd like it to read, each licensee shall attest as to the licensee's successful completion, so remove, sign the attestation on the renewal application. Then on page 5, line 3 to 9, it states, The board my conduct an audit of a licensee for compliance with the continuing competency requirements and establish quidelines for random audits. The board shall inform licensees of the licensees' selection for audit. Within sixty days of notification, the licensee shall provide the board with documentation of successful completion of the continuing competency requirements. For the pharmacy board everything is in the laws so you don't need to promulgate rules to implement. Their audit language reads "the board may conduct random audits to determine compliance with the continuing education requirement. The board shall provide written of an audit to a licensee randomly selected for audit. Within sixty days of notification, the licensee shall provide the board with documentation verifying compliance with the continuing education requirement"

The Chair asked why it has to be "random".

The EO stated because there is over 20,000 nurses and logistically we cannot audit all of them.

The Chair stated what she means is that we should be able to select specific licensees, not just random licensees.

The DAG stated that she believes what the Chair is trying to say is if there is reason to believe a certain licenses may not have complied; the board should be able to select them for audit.

The EO stated if you know of someone who signed the attestation but did not comply, then you can report it.

The DAG stated we could just take out the word "random" then it would say "may conduct an audit".

Mr. Hoban agrees with removing the word random, then it would allow flexibility.

The EO stated she will gather any further recommendations that the Board may have and send them to Ms. Suetsugu.

Ms. Suetsugu stated she still has other meetings also, and after all the meetings are done she will compile everyone's recommendations.

The Chair stated another suggestion is since this is the Center's bill, perhaps they should provide some educational programs.

Ms. Kodama stated most hospital contracts provide CEU's for free to their nurses.

The Chair stated that's true that most hospitals do, however she does not know if the Hawaii State Hospital does and the last time this legislation went forward, it was stopped because of how much time and money it would cost the employees.

The EO asked what HNA's recommendations were.

Ms. Suetsugu stated she will collectively get feedback and provide a summary of the recommendations at the end; however one of the things HNA recommended was for first time renewals, that they be exempt from the continued competency requirement.

The Chair stated that would be okay for first graduates, but what if they are coming from another state and this is only their first renewal in Hawaii, but they have been licensed for several years in another state.

Ms. Suetsugu stated correct, these are just suggestions and she will be compiling all the recommendations and have them vetted through all those who will be supporting this bill.

The DAG asked if Hawaii Health Systems Corporation (HHSC) has been contacted.

Ms. Suetsugu stated she has not contacted them, but she will work on setting up a meeting.

Mr. Hoban stated you should also reach out to Healthcare Association of Hawaii (HAH).

Ms. Suetsugu stated she did already send HAH a copy of the bill. Getting back to HNA's recommendations, they also stated on page 4, line 12, right now it reads, <u>The board may consider request s for extensions on a case-by-case basis</u>, they want to add a second sentence that defines proof or what is appropriate documentation.

The EO stated the Board will work on that.

Ms. Suetsugu stated on page 5, under **Learning activity options**, HNA wanted to add precepting as credit.

The Chair stated the concern she would have with that is there is no standard for precepting. We would have to define what precepting would involve.

Board of Nursing Minutes of October 2, 2014 Meeting Page 6

Ms. Suetsugu stated on page 5, line 3, reads <u>The Board may conduct an audit</u>. HNA is recommending that we add "for the preceding 2 year period". Because the providers for authorized competence will be set by the Board, they want a readily accessible list of providers.

The EO asked if the Center could provide a list to Board that they can start with.

Ms. Suetsugu stated she will work on getting the Board a list. The last thing HNA recommended was on page 8, starting on line 6, right now it reads <u>including a false</u> attestation, HNA's recommendation is, "including a willful submission of a false attestation".

The Chair asked how we would ever be able to determine that it's willful.

The EO stated just to clarify, the effective date will be June 30.2019. That is when the licensees will begin attesting. License period beginning July 1, 2017 is when they start doing the continued competency.

Ms. Suetsugu stated right now the language reads, starting July 1, 2017, should we clarify that?

The EO stated no, it's clear. The Board would need time to notify the nurses.

Ms. Suetsugu thanked the Board for their time.

## <u>American Nurses Credentialing Center (ANCC) – Retire Exam for Pediatric Clinical Nurse</u> Specialist, Effective 12/31/2015

The EO reported that ANCC will be retiring the Pediatric Clinical Nurse Specialist Certification (PCNS-BC) effective December 31, 2015. The credential will not be retired, only the exam. Nurses currently certified as PCNS-BC may still use their credentials and maintain the certification through timely renewal. ANCC will accept new applications to sit for the PCNS-BC exam through March 31, 2015. Eligible applicants must pass the exam before December 31, 2015 to achieve PCNS-BC certification.
