# Executive Officer's Report:

### Conferences/Seminars/Meetings

Board Member Orientation, December 5, 2014, State Capitol – Judy Kodama, Katharyn Daub

The EO reported Ms. Kodama and Ms. Daub have confirmed their attendance at the Board Member Orientation being held tomorrow at 8:30 a.m. in the State Capitol Auditorium.

<u>2015 NCSBN Annual Institute of Regulatory Excellence (IRE) Conference, January 13-15, 2015, Charleston, South Carolina – Glenda Tali</u>

The EO reported the Vice Chair Ms. Tali will be attending the 2015 NCSBN Annual Institute of Regulatory Excellence Conference being held January 13-15, 2015 in Charleston, South Carolina.

### 2014 Legislature – Status Report

### Continuing Competency Bill - Draft

The EO reported that she prepared another draft based on the comments from the Boards last meeting. Regarding removing the word "random" from the audit requirement, the EO's from the other Boards and Commissions that have a CE requirement were polled to find out what areas do and do not conduct an audit and if their statute indicated "random". Out of 17 areas that have a CE requirement, 6 do not have an audit requirement, and 11 areas do audits, but only 9 areas indicate "random" audit.

The Vice Chair asked if there is a percentage of licenses that are audited.

The EO stated the average is 5%.

The Chair stated we're not saying we can't do the audit randomly, we're just saying if we put in that it is a "random" audit that restricts the Boards ability to audit certain individuals or organizations.

The EO stated that she was concerned with the Board "targeting" a specific individual or organization for audit without statutory language it appears to be arbitrary.

The DAG stated the term "continuing competency" is used on page 2, then on page 3, they use the term continuing education or learning activity, and then on page 5 it goes back to continuing competency.

The Chair stated the concept of continuing competence was kept from the original bill because the data shows CE does not guarantee continued competence, which is why there are also learning activity options. For example, you could participate in a research proposal, which is continuing education, but it is included as a learning activity that would lead to competence. Competence is demonstrated or achieved through these learning activities, which includes continuing education.

#### Ms. Kodama arrived 8:39 a.m.

The DAG stated the administrative rules would then have to be cleaned up in regards to continuing education. On page 7, starting on line 17, the definition of "continuing competence", self-assessment and subsequent reassessment needs to be removed.

#### Mr. Hoban arrived 8:41 a.m.

The Chair stated continued competence does not mean "maintaining documentation", that is not the definition of continued competence. This definition actually does not need to be included; "competence" is already defined.

It is the consensus of the Board to strike lines 17 through 20 on page 7.

Mr. Joslyn asked what the deadline is to provide this information to the Center.

The EO stated that the legislature convenes in January, so we need to get the Boards comments to them as soon as possible.

Mr. Joslyn stated that this bill seems very piece-meal and should be cleaned up and defined.

The Chair stated she doesn't disagree with Mr. Joslyn but the Board is just being asked to provide their comments, this is not the Nursing Boards bill.

The EO asked if the learning activities given are also acceptable for national certification.

The Chair stated part of it is, but not all.

Mr. Hoban stated these activities are targeted to the academic nurse. They are not for the hands-on patient care nurses. What is the simplest way to encourage continued learning on a regular basis for the majority of the nurses out there?

Ms. Kodama stated the simplest would be CEU's.

After further discussion, it was the consensus of the Board to have the EO draft a bill that requires nurses to complete continuing education courses in order to renew their nurse licenses. The members emphasized keeping it as simple as possible because the current language is confusing.

# Report on Attendance at the Board of Dental Examiners November 17, 2014 Meeting – Support of Proposed Amendments to HAR 16-79 Relating to CRNAs

The EO reported that she attended the Board of Dental Examiners ("BODE") meeting that was held on November 17, 2014 where they announced proposed changes to their rules as follows:

§16-79-78 Administration of general anesthesia and sedation.

In lieu of the requirements in paragraphs (1)(A) and (B), a licensed dentist may receive a written authorization or permit to use general anesthesia, deep sedation or moderate (conscious) sedation, if the licensed dentist employs or works in conjunction with a physician licensed pursuant to chapter 453, HRS, who [is a member of the] specializes in anesthesiology [staff of an accredited hospital] or a certified registered nurse anesthetist licensed pursuant to chapter 457, HRS, who is actively practicing and in good standing; provided that the [anesthesiologist] physician who specializes in anesthesiology or certified registered nurse anesthetist shall remain on the premises of the dental facility until the patient is fully recovered and discharged from the facility.

The EO stated she will be attending the BODE January 26, 2015 meeting where they will be voting on the proposed changes. She will also be sending a letter to the BODE from the Board of Nursing thanking them for their consideration and this language and if they have any questions to feel free to call on the Board of Nursing.

# Correspondence

Are Hawaii nursing applicants required to disclose/report traffic violations? The Board reviewed an email inquiry asking if the following question on the renewal application is to include information on minor traffic violations:

1. In the past 3 years have you been convicted of a crime in which the conviction has not been annulled or expunged?

After a brief discussion the Board determined that traffic violations that have not been annulled or expunged need to be reported/disclosed on any application filed with the Board.
