# Executive Officer's Report:

## HAR Title 16, Chapter 95 – Status Report

The EO reported that a request to hold a public hearing was sent to the Governor's office on December 3, 2014. No response has been received yet.

## Conferences/Seminars/Meetings

The EO reported that the Board of Pharmacy Laws and Rules Committee met today before the Board meeting and discussed collaborative agreements, durable medical equipment providers and compounding pharmacies.

## NABP Vet-VIPPS Survey, Maui, Hawaii, November 16.2014 - Mary Jo Keefe

Ms. Keefe reported that Don Williams was the representative from NABP. They did a tour of a small closed veterinary pharmacy where the pharmacist is there about 3 days a week. They discussed human resources, customer service, inventory management, shipping, administration, staff and IT computer systems.

NABP Interactive Member Forum, December 2-3, 2014, Northbrook, Illinois – Mary Jo Keefe Ms. Keefe reported there were a lot of people in attendance that regularly go to NABP meetings. They discussed pharmacy tech training, education requirements and exams. One topic that was of interest was "tech check tech training" with bar code technology, where the technicians are doing the final check of the prescription in the pharmacy. Also discussed were inspectors and calling them "practice advisors" instead of inspectors. On the topic of pharmacists, they discussed ordering lab test outside of collaborative agreements, prescriptive authority, privacy measures and conflict of interest.

New Board Member Orientation, December 5, 2014, 8:30 – 12:30 p.m., State Capitol Auditorium The EO reported the Chair, Ms. Keefe and Dr. Chock attended the New Board Member Orientation on December 5, 2014 at the State Capitol Auditorium.

## State News Roundup, November 2014

The Chair reported that effective September 17, 2014, Ohio House Bill 314 requires prescribers to obtain informed consent form a parent or guardian prior to initial issuance of a prescription for an opioid pain medication to a minor. While this new law primarily impacts prescribers, both Ohio laws and rules and federal laws and regulations place a corresponding responsibility on the pharmacist to use his or her professional judgment to determine if a prescription has a legitimate medical purpose and is compliant with all state and federal laws.

Another new law enacted by the Ohio General Assembly, House Bill 341, requires a prescriber, prior to issuing a prescription for an opioid analgesic or benzodiazepine, to query the Ohio Automated Rx Reporting System (OARRS) database. It also requires all pharmacists to register with OARRS by September 15, 2015.

Effective January 1, 2015, Ohio Administrative Code (OAC) Rule 4729-9-14 requires each prescriber or terminal distributor of dangerous drugs to take inventory of all stocks of controlled substances (CS) on hand every year following the date on which the initial inventory is taken. This is a change from the previous version of the rule that required a CS inventory every two years.

Also effective January 1, 2015, OAC Rule 4729-9-21 requires drugs compounded in a pharmacy to adhere to United States Pharmacopeia Chapter 795 for nonsterile compounded drugs and 797 for sterile compounded drugs. Additionally, all compounded prescriptions must also adhere to Section 503A of the Federal Food, Drug, and Cosmetic Act.

The Oregon State Board of Pharmacy recommends and encourages licensees to pursue ongoing CE opportunities for cultural competency. For purposes of maintenance of licensure, the Board considers CE in cultural competency to be relevant to the current practice of all licensees, and licensees may use this type of CE toward satisfying the required CE hours for license renewal.

The Oregon Board further notes that in order for the state to achieve the triple aim of improving health, improving care, and lowering cost, providers must be responsive to the needs of the diverse populations.

In Virginia, effective January 1, 2015, it is unlawful for any pharmacy or retail distributor to knowingly or intentionally sell or distribute a product containing dextromethorphan to a minor under the age of 18.

In North Dakota they are requiring the use of the Prescription Data Monitoring Program (PDMP) under certain circumstances effective October 1, 2014.

In Tennessee they are encouraging pharmacies to audit their controlled substances more closely. They are requiring a count and reconcile of any loss or surplus of medications based on your dispensing.

## State Regulation of Wholesale Distributors and Third-Party Logistics Providers

The Board reviewed a memorandum from NABP asking how the state plans to license wholesale distributors and third-party logistics providers (3PLS). Currently, the law defines a wholesale distributor as: a person (other than a manufacturer, a manufacturer's co-licensed partner, a third-party logistics provider, or repackager) engaged in wholesale distribution. The law further defines a 3PL as: an entity that provides or coordinates warehousing or other logistics services of a product in interstate commerce on behalf of a manufacturer, wholesale distributor, or dispenser of a product, but does not take ownership of the product, nor have responsibility to direct the sale or disposition of the product. Furthermore, the new law specifically requires that 3PLs be licensed separately from wholesale distributors: State Regulation of Third-Party Logistics Providers. – No State shall regulate third-party logistics providers as wholesale distributors.

The following are questions asked by NABP with the Board's responses:

- 1. Does your state currently license wholesale distributors? **Yes.**
- 2. Does your state currently license 3PLs? No.
- If the present licensure category is wholesale distributor, does your state plan on changing that to separate the licensure of 3PLs in accordance with Title II of the DQSA? No.
  - a. If no, can you explain why?
     Hawaii does not have a compelling reason to license 3PLs at this time and is not clear on the purpose of separating licensure.

This memorandum was also referred to the Laws and Rules Committee for discussion.

## Pharmacists Administering intramuscular injections (immunizations)

The Board reviewed an email inquiry asking if the successful completion of coursework or inservice training approved by The Accreditation Council for Pharmacy Education (ACPE) or The American Pharmacist Association (APA) in administering immunizations would fulfill the qualifications set forth in HRS §461-1(D) and that is the only State requirement for the pharmacist to administer injections within the pharmacy practice.

After a discussion and review of the definition of "Practice of pharmacy" under HRS Chapter 461 and discussion of their previous decision in August 2013 regarding a similar matter, it is the Board's informal interpretation that pursuant to the following definition, a Hawaii pharmacist may administer injections, including the intramuscular psychiatry injections in the deltoid if the pharmacist has completed the approved training as described below under the definition of "Practice of pharmacy", has an existing collaborative agreement with a licensed physician, has a valid prescription from the prescriber and adheres to any additional training recommendations by the manufacturer of the drug:

#### "Practice of pharmacy" means:

- (1) The interpretation and evaluation of prescription orders; the compounding, dispensing, and labeling of drugs and devices (except labeling by a manufacturer, packer, or distributor of nonprescription drugs and commercially legend drugs and devices); the participation in drug selection and drug utilization reviews; the proper and safe storage of drugs and devices and the maintenance of proper records therefore; the responsibility for advising when necessary or where regulated, of therapeutic values, content, hazards, and use of drugs and devices;
- (2) Performing the following procedures or functions as part of the care provided by and in concurrence with a "health care facility" and "health care service" as defined in section 323D-2, or a "pharmacy" or a licensed physician, or a "managed care plan" as defined in section 432E-1, in accordance with policies, procedures, or protocols developed collaboratively by health professionals, including physicians and surgeons, pharmacists, and registered nurses, and for which a pharmacist has received appropriate training required by these policies, procedures, or protocols:
  - (A) Ordering or performing routine drug therapy related patient assessment procedures;
  - (B) Ordering drug therapy related laboratory tests;
  - (C) Initiating emergency contraception oral drug therapy in accordance with a written collaborative agreement approved by the board, between a licensed

- physician and a pharmacist who has received appropriate training that includes programs approved by the American Council of Pharmaceutical Education (ACPE), curriculum-based programs from an ACPE-accredited college of pharmacy, state or local health department programs, or programs recognized by the board of pharmacy;
- (D) Administering drugs orally, topically, by intranasal delivery, or by injection, pursuant to the patient's licensed physician's order, by a pharmacist having appropriate training that includes programs approved by the ACPE, curriculumbased programs from an ACPE-accredited college of pharmacy, state or local health department programs, or programs recognized by the board of pharmacy;
- (E) Administering:
  - (i) Immunizations orally, by injection, or by intranasal delivery, to persons eighteen years of age or older by a pharmacist having appropriate training that includes programs approved by the ACPE, curriculumbased programs from an ACPE-accredited college of pharmacy, state or local health department programs, or programs recognized by the board of pharmacy; and
  - (ii) The influenza vaccine to persons between fourteen and seventeen years of age pursuant to section 461-;

This is an informal interpretation for explanatory purposes only and is therefore not to be considered binding on the Board.
