Hawaii State
Center for Nursing:
Survey.

Dr. LeVasseur was present and provided the Board with a list of new questions that will be added to the Hawaii State Center for Nursing ("Center") Workforce Survey.

Dr. LeVasseur stated there are fifteen items that are being added to the survey. Predominately they are trying to get information on nurses that are sitting in leadership roles, for example those that are on boards and commissions. The Center wants to identify how many nurses are sitting in these types of positions and what needs to be done to encourage nurses to become active in regards to boards and commissions and take leadership roles. Some of the other questions have to do with looking at new graduates and then other questions have to do with identifying individuals who are in other types of programs like online or out-of-state education programs. There has been quite a proliferation of online programs within the last five years so the assumption is there is probably a significant number. The last piece has to do with APRNs and finding out who as an APRN is operating within their scope of practice.

Can an LPN Accept Verbal Orders?

The Board reviewed an email inquiry asking whether or not LPN's can take verbal orders in Hawaii.

After some discussion and review of Hawaii Revised Statutes ("HRS"), §457-1, definition of "The practice of nursing as a licensed practical nurse", it appears that the statutes do not specifically address this. However, nurses who do receive and carryout verbal orders must comply with the documentation requirement that includes, but is not limited to, documenting nursing care provided accurately and timely.

In addition, HRS §457-1.5 Practice of nursing. (b) states, "The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to specific procedures in any particular work setting. "

In accordance with Hawaii Administrative Rules §16-201-90, the interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

Can RN, with Appropriate Training, Use Lasers and Cosmetic Injectables?

The Board reviewed an email inquiry asking if there are any prohibitions by the Board which would inhibit the use of lasers and cosmetic injectables by an RN. They also reviewed an email from the Hawaii Medical Board responding to the same question.

After some discussion and review of Hawaii Revised Statutes ("HRS") Chapter 457, it appears that the procedures indicated may not fall under the nurse practice act.

In addition, HRS §457-1.5 Practice of nursing. (b) states, "The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting. "

In accordance with Hawaii Administrative Rules §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

Can an RN/APRN, with Appropriate Training, Place a Stimulation Lead?

The Board reviewed an email inquiry asking if an RN and/or APRN can perform a procedure involving placement of a stimulation lead to send electrical pulses to an area near the sacral nerve.

After some discussion and review of Hawaii Revised Statutes ("HRS"), §457-1, definition of "The practice of nursing as a registered nurse", it appears that the statutes do not specifically address this procedure. However, it may be that an APRN who has prescriptive authority, practicing within their specialty and who has received the appropriate education and training and has demonstrated competency may be able to perform such procedures. Since APRNs are considered primary care providers, they are not required to be "supervised" when practicing within their scope of practice.

In addition, HRS §457-1.5 Practice of nursing. (b) states, "The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness

of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting. "

In accordance with Hawaii Administrative Rules §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

Can an APRN, with Appropriate Training, Perform Spinal Fact Joint Injections, Epidural Steroid Injections and Lumbar Radio Frequency Ablation?

The Board reviewed an email inquiry asking if an APRN can perform Spinal Fact Joint Injections, Epidural Steroid Injections and Lumbar Radio Frequency Ablation after receiving the appropriate training.

After some discussion and review of Hawaii Revised Statutes ("HRS"), §457-1, definition of "The practice of nursing as a registered nurse", it appears that the statutes do not specifically address this procedure as a basic nursing task. However, it may be that an APRN who has prescriptive authority, practicing within their specialty and who has received the appropriate education and training and has demonstrated competency may be able to perform such procedures.

In addition, HRS §457-1.5 Practice of nursing. (b) states, "The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting. "

In accordance with Hawaii Administrative Rules §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

Can an APRN Dispense Medication, Including Controlled Substances?

The Board reviewed an email inquiry asking the following questions:

1. Is an APRN permitted to dispense prescription medication?
2. Can an APRN dispense if his/her controlled substance license specifically grants him/her the ability to dispense prescription medication?
3. If an APRN sees a patient while the provider is in the office, can the APRN dispense to the patient under the provider?

After some discussion the Board determined that pursuant to the following, an APRN may not "dispense" a prescription drug:

Hawaii Administrative Rules ("HAR"), §16-89-122(c) state, "The APRN shall comply with all applicable state and federal laws and rules relating to prescribing and administering of drugs. The APRN with prescriptive authority shall only prescribe, order and dispense medical devices and equipment appropriate to the APRN's specialty."

In addition, although an APRN with prescriptive authority and who is registered with the Department of Public Safety, Narcotics Enforcement Division and the Drug Enforcement Agency to prescribe controlled substances, pursuant to the following, an APRN is not allowed to "dispense" a controlled substance:

Hawaii Revised Statutes ("HRS") 329 defines an advanced practice registered nurse with prescriptive authority as, "a person licensed under section 457-8.6 who is registered under this chapter to administer or prescribe a controlled substance; provided that an advanced practice registered nurse with prescriptive authority shall not be authorized to request, receive, or sign for professional controlled substances samples." Also under the definition "Practitioner" in HRS 329, it states, "An advanced practice registered nurse with prescriptive authority licensed and registered under section 329-32 to prescribe and administer controlled substances in the course of professional practice in this State;" Both sections do not allow an APRN to "dispense" any controlled substances.

Regarding the question on whether or not an APRN can "dispense" to a patient under another practitioner, based on the above mentioned HAR, an APRN may not dispense any prescription drugs.

HRS §457-1.5 Practice of nursing. (b) states, "The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting. "

In accordance with Hawaii Administrative Rules §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

Can an APRN Order and Dispense Birth Control Devices, Pill, Patches or Shots?

The Board reviewed an email inquiry asking if an APRN can order birth control devices, pills, patches, shots, etc., directly from a manufacturer.

After some discussion the Board determined that pursuant to the following, an APRN may prescribe, administer, order and "dispense" prescription devices:

Hawaii Administrative Rules ("HAR"), §16-89-122(c), "The APRN shall comply with all applicable state and federal laws and rules relating to prescribing and administering of drugs. The APRN with prescriptive authority shall only prescribe, order and dispense medical devices and equipment appropriate to the APRN's specialty."

In addition, HRS §457-1.5 Practice of nursing. (b) states, "The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting. "

In accordance with Hawaii Administrative Rules §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

Fitzgerald Health Education Associates Clinical Pharmacology for NPs and Advanced Practice Clinicians – Credit for Continuing Education?

The Board reviewed an email inquiry and course summary asking if the course meets the requirements for continuing education for APRN prescriptive authority.

After careful consideration, the Board approved, by consensus, the course, "Clinical Pharmacology for NPs & Advanced Practice Clinicians" presented by FHEA Associates as meeting the pharmacology course requirement for prescriptive authority for APRNs.

Coverage of Topical Fluoride Varnish Application

The Board reviewed a memorandum from the State of Hawaii Department of Human Services, Med-QUEST Division, Clinical Standards Office, regarding the coverage of Topical Fluoride Varnish application. The memo states that qualified Primary Care Providers ("PCP") includes physicians and nurse practitioners.

APRNs Admitting Patients at Hawaii Licensed Hospitals

The Board reviewed an email citing the following statute and inquiry:

HRS §457-5(a)(1) authorizes the Board of Nursing ("Board") to adopt rules governing, among other things, the definition of the scope of practice of nursing. Pursuant to the authority granted by the statute, the Board has adopted Hawaii

Administrative Rules ("HAR") Chapter 16-89. HAR §16-89-81(c)(1)(H) states that activities within the scope of practice of a Nurse Practitioner, one of the four subspecialties of APRNs recognized by the rules, includes "Admit and discharge clients for inpatient care at facilities licensed as hospitals, long term care facilities or hospice." Similarly §16-89-81(c)(3)(B)(v) states that activities within the scope of Certified Nurse Midwives, another recognized APRN subspecialty, include "Admit clients for inpatient care at facilities licensed as hospitals or birth centers in the State."

"My client is a federally qualified health center, which seeks hospital privileges for certain of its staff members. The hospital has refused to credential them, on the ground that Hawaii law does not permit APRNs to have admitting privileges. Would you please advise whether the statutes and regulations cited above authorize APRNs to obtain privileges to admit patients at Hawaii licensed hospitals?"

After some discussion and a review of the rules and statutes cited above, the Board determined that APRNs, within their scope, *may* admit and discharge clients for inpatient care at facilities licensed as hospitals, long term care facilities or hospice. However, any rules mandated by the federally qualified institution must be followed.
