## Approval of the Minutes:

The Chair called for a motion in regards to the minutes of the February 5, 2015 meeting.

Upon a motion by Mr. Joslyn, seconded by the Vice Chair, it was voted on and unanimously carried to approve the minutes of the February 5, 2015 meeting as circulated.

## Chair's Report:

#### Announcements/Introductions

The Chair announced that Montana became the 25th state to join the Nurse Licensure Compact.

She also reported that Georgetown University School of Nursing projected in 5 years there will be a nursing shortage, which is different from the Health Resources and Administration ("HRSA") December 2014 report that was shared with the Board at its January 2015 meeting.

The EO reported Diane Corn, Attorney for the Regulated Industries Complaints Office ("RICO") will be attending the 2015 NCSBN Discipline Case Management Conference, June 1-2, 2015 in Indianapolis, Indiana.

## 2014 Legislature – Status Report

The EO reported on the following bills:

 HB 354, HD1/SB 735, SD1 – Relating to Nurses (Continuing Competency Bill)

The EO stated HB 354 HD 1 was passed out by the Committee on Consumer Protection with the Board's recommendations; however they have not come out

with an HD 2 yet, and that SB 735, SD1 was also passed out of the Consumer Protection and Commerce Committee with the Board's recommendations.

The Chair stated she still has concerns because it states "board-recognized" learning activity and not "board-approved".

Mr. Joslyn stated all learning activities should say "board-approved".

Ms. Kodama arrived 8:50 a.m.

The EO stated for HB 354 and SB 735 we will recommend insertion of "board-approved" in the "learning activity options" section of the bill instead of "board-recognized".

It was the consensus of the Board to support HB 354 and SB 735 with amendments.

The EO stated should this bill pass; we will then have to get the word out to the licensees via mail, webpage, employers, etc.

Mr. Joslyn asked shouldn't the Hawaii State Center for Nursing do that?

The EO stated that they will definitely help disseminate the information.

## • HB 1212/SB 729 – Relating to Advance Practice Registered Nurses

The EO stated these bills clarify the role of advanced practice registered nurses in sections of Hawaii Revised Statutes relating to emergency hospital admission and involuntary hospitalization. HB 1212 was not scheduled for hearing, but that SB 729 is moving through unamended and should cross over to the House.

It was the consensus of the Board to continue to support SB 729.

#### SB 807,SD1 – Relating to Health

The EO stated SB 807 that establishes the narcotics advisory committee to recommend acceptable topics and curriculum for the continuing medical education program now includes 2 APRNs but it does not specify that the APRNs should have prescriptive authority.

After some discussion, upon a motion by the Chair, seconded by Mr. Joslyn it was voted on and unanimously approved to support SB 807, SD1 with the amendment to clarify that the APRN serving on the narcotics advisory committee be an APRN with prescriptive authority to allow more expertise from a prescribing APRN.

## HB 253, HD1 – Relating to Vaccinations

The EO stated this bill was amended to include APRNS to work collaboratively with a pharmacists in providing medication therapy to patients, and asked should this bill also be clarified to include APRNs with prescription authority?

After some discussion, upon a motion by the Chair, seconded by Mr. Joslyn it was voted on and unanimously approved to support HB 253, HD1 with the amendment to clarify an APRN with prescriptive authority.

## • SB 302,SD1 – Relating to Drug Overdose Prevention

The EO stated this bill creates immunity for individuals who prescribe, possess, or administer an opioid antagonist such as naloxone hydrochloride during an opioid-related drug overdose. The bill includes "Nurse Practitioner" ("NP") as a healthcare professional and asked if it should be amended to "APRNs with prescription authority"?

The Chair stated it does not have to be an APRN with prescription authority; it can be just an APRN because this is an emergency situation.

The EO stated according to the bill they will be able to prescribe, dispense and distribute, and an APRN without prescriptive authority cannot prescribe.

The Chair stated in the description of the bill it says, prescribe, possess, or administer.

The EO stated that is in the description; however the bill actually allows the healthcare professional, which right now includes NPs, to prescribe, dispense and distribute. The bill goes on to say, "Notwithstanding any other law or regulation, a healthcare professional otherwise authorized to prescribe an opioid antagonist may, directly or by standing order, prescribe, dispense, and distribute an opioid antagonist to an individual..." So this bill would allow an APRN without prescriptive authority to dispense this drug.

Mr. Joslyn asked why only limit it to APRNs? Why can't an RN administer?

The Chair stated this isn't about administering; it is for prescribing and dispensing.

The EO stated the description is very different from what is in the bill. On page 3, starting on line 16, it says ... (a) "Prescription orders for naloxone hydrochloride are exempt from the pharmacy license requirements and pharmacy permit requirements of chapter 461. (b) Notwithstanding any other law or regulation, a

person or organization acting under a standing order issued by a healthcare professional licensed under chapter 453 who is otherwise authorized to prescribe an opioid antagonist may store an opioid antagonist without being subject to chapter 328 except part VII and may dispense an opioid antagonist without charge or compensation." So because it does not mention chapter 457, which is your nurse practice act, it does not apply to nurses. So they cannot store an opioid antagonist without being subject to chapter 328.

The Chair stated that unfortunately there are a lot of situations where patients who have substance abuse histories come to social clubs, mental health centers, and even substance abuse treatment centers that are staffed by other professionals that are not licensed physicians.

The DAG stated if you separated out the activity of administer versus prescribe and dispense, then you can say an APRN with prescriptive authority can administer, prescribe and dispense and any other nurse, like an APRN, RN and LPN can administer.

Mr. Joslyn stated that sounds good.

It was the consensus of the Board to support SB 302, SD1 with amendments to clarify that an APRN with prescriptive authority be able to prescribe, dispense and administer naloxone hydrochloride and that an APRN, RN, and LPN may administer naloxone hydrochloride under their scope of practice.

## **Proposed Increase in License and Renewal Fees**

The EO stated the basis of the proposed fee increase is to update the division's database which has not been updated since 1984. The exact amount of the proposed increase has not been determined yet.

## NCSBN Standards Development Committee – Criminal Background Checks

The Board was provided a letter from the NCSBN Standards Development Committee ("NSDC"). The NSDC drafted its first proposed standard: Criminal Background Checks for Licensure as a Nurse.

After a review of the letter and proposed standards, upon a motion by the Vice Chair, seconded by Mr. Joslyn, it was voted on and unanimously carried to approve the proposed standards.

## Can an APRN "Supervise" Medical Assistants to Administer Injections?

The Board reviewed an email inquiry asking the following question:

1. As an NP, am I allowed to supervise my medical assistants to give injections in addition to our doctor?

After some discussion, it was the consensus of the Board that an RN and/or APRN may "supervise" unlicensed assistive personnel based on the following definitions and sections:

## §16-89-2 Definitions. As used in this chapter:

"Direct supervision" means that the registered nurse assesses the condition to be treated, authorizes each special task to be performed, remains on the premises, and personally evaluates the performance of the unlicensed assistive personnel.

"Supervision" means the process of critical watching, directing, and evaluating another's performance.

"Unlicensed assistive person" means an individual who is not licensed to practice nursing, but who provides tasks of nursing care delegated by a registered nurse.

The Board also reviewed the following section regarding "delegation":

#### SUBCHAPTER 15

DELEGATION OF NURSING CARE TASKS TO UNLICENSED ASSISTIVE PERSONNEL

§16-89-100 Purpose. (a) Only a registered nurse has authority to practice professional nursing; therefore, only the registered nurse has authority to delegate nursing. It is the intent of the board that the delegation of tasks of nursing care to unlicensed assistive personnel be the exception rather than the rule unless the registered nurse can justify the need for delegation. The board believes that unlicensed assistive personnel can be utilized to provide tasks of nursing care under the specific delegation and supervision of a registered nurse and not under any licensed practical nurse. Nothing in this subchapter shall limit a licensed practical nurse from providing care within the scope of their practice. A registered nurse may delegate in any setting at any time; provided that when the registered nurse is not regularly scheduled and not available to provide direct supervision, the registered nurse shall provide indirect supervision. (b) When delegating a task, function, or activity, the nurse shall use the NCSBN delegation decision-making process and the protocols contained in the NCSBN documents recognized by the Board as a model. (c) In public school settings, medication shall be administered by school aides in accordance with the regulations and local policies of the department of health and the department of education. Those regulations and policies shall comply and coordinate with applicable federal and state laws,

including but not limited to, part III, subpart F of chapter 302A, HRS (relating to school health services program, including statewide requirements for medication administration) and [Hawaii Administrative Code] section 11-146-4.

**§457-1.5 Practice of nursing.** (b) states, "The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting."

Consequently, in accordance with Hawaii Administrative Rules §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.
