- b. Prometric Pest Control Exam Calculators

The Executive Officer informed the Board that Roman Dycus of Dow AgroSciences (Dow) has donated 8 Fumiguide calculators to be distributed by Prometric for the pest control exams.

Mr. Dycus informed the Board that the Vikane Fumiguide calculators have been in use for over 20 years. The calculator is able to calculate accurate dosages for blow-outs and can monitor jobs from 2 to 72 hours.

Mr. Rourk asked the Board if they would accept a former PCFR's 2005 BR-3 job experience for his current BR-3 application because there are very few subterranean termite jobs in Kona that he can use for his field experience. Mr. Manago referred Mr. Rourk to HAR Chapter 16-94-17(b)(2), which states that:

“The applicant shall have been an applicator in at least twenty-five jobs within the last four years in the specific branch for which application is being made. . .”

Mr. Ono also informed Mr. Rourk that there are subterranean termites in Kona, Honauanau and Kailua areas.

The Board reviewed Shelby Jordan's Branch 2 exam waiver request for the PCFR reapplication for Branches 2 and 3. Shelby Jordan was approved to take the exams for Branches 1, 2 and 3 in 2012, passed the exam for Branch 2 but failed to complete the licensing process. It was moved by Mr. Ono, seconded by Mr. Manago and unanimously carried to deny Shelby Jordan's request for waiver of the Branch 2 exam already taken and passed in 2012 because the reapplication is beyond the required one year period pursuant to HRS Chapter 16-94-35.1, which states that:

“An examination shall not be required when the applicant, within a period of one year prior to application, has previously qualified by written examination or was licensed in good standing or on an inactive status, . . .”

Scope:

a. Rule Revision

Executive Officer Ferrer informed the Board that Executive Officer Tamanaha continues to work on the Ramseyer version of HAR Chapter 16-94-17.

On behalf of Executive Officer Tamanaha, Executive Officer Ferrer requested the Board to review the following changes to §16-94-18:

§16-94-18 Exhibits required. (a) Individual applicants for licenses shall furnish the board with the following exhibits:

- (1) Two certificates to support experience qualifications on a form prescribed by the board. One certificate shall be completed by ~~[an]~~ the individual operator or RME licensed in the branch for which the

application is made and who provided the supervision; and. . .

- (b) Applicants for a business license shall file:
- (5) Evidence that the entity is properly registered with the department's business Registration Division (BREG)
- (A) If the entity has been registered in this state for less than one year, provide a file stamped copy of the document filed with BREG; or
- (B) If the entity has been registered in this state for more than one year, provide a current certificate of good standing issued not more than one year ago. . .

(c) Pest Control entities shall submit a letter signed by the officers of the corporation, partners of a partnership or limited liability partnership, members or managers of a limited liability company, or members of a joint venture designating the principal RME or additional RMEs. This letter shall also be countersigned by the RME and shall accompany the application for license. . .

After further review, it was moved by Mr. Manago, seconded by Mr. Montalbo and unanimously carried to approve the changes to HAR Chapter 16-94-18.
