Call to Order: The Chair called the meeting to order at 8:30 a.m. at which time quorum was established.

**Approval of the Minutes:**

The Chair called for a motion in regards to the minutes of the March 5, 2015 meeting.

Upon a motion by Ms. Daub, seconded by the Vice Chair, it was voted on and unanimously carried to approve the minutes of the March 5, 2015 meeting as circulated.

**Chair's Report:**

**Announcements/Introductions**

The Chair asked the audience to introduce themselves.

**Report on Attendance at 2015 NCSBN Midyear Meeting**

The Chair reported the meeting in many ways was very contentious because the entire focus was on the compact licensure. The twenty-six states that were part of the original compact will have to re-sign onto the new compact, or they can choose not to. So for a six month period, you could have two compacts. The new compact is much more rigorously structured so that people will have to meet all the standardized requirements, they will not be allowed to do any modifications. The rationale for the new compact is that if nothing is done, because of the issue related to telehealth, the federal government is looking at federal licensure, and that would preempt the compact. As a state, it would behoove us to look at the situation more closely. The compact was just revised at the Midyear meeting; and there is an emergency meeting on May 4, 2015 to look at the final compact before the annual meeting. Most of the twenty-six states that already participate said they were happy with it; it has helped their executive officers organize things, the only state that had issues with it, and is considering withdrawing, is Rhode Island, and the reason is because of their unions in the state. The unions are concerned that if you have nurses that are licensed in multiple states, and should they go on strike or have a negotiating issue; it would be too easy to bring in nurses.

The DAG asked if there are significant differences between the old and new compact?

The Chair stated yes, some of the requirements are much more rigorous as far as nursing standards. Clearly they are looking to define what the criminal background check will be.

The EO asked if any state that joins the compact has to participate in NURSYS?

The Chair stated yes. They did say that if there was a financial burden, they would help with that. However, no state said they had a financial burden.

Vice Chair's Report:

**Education Committee Report**

The Vice Chair reported on the following from the March 4, 2015 Education Committee Meeting:

1. Kauai Community College – New Nursing Program Director, Tracy Stogner – Committee recommend Board accept and approve Tracy Stogner as the new Nursing Program Director for Kauai Community College

New Business/Correspondence:

1. Request for Clarification of Education Rules – Inquiry regarding substitution of clinical hours – The Committee determined that there is no regulation, law or rule that allows for substitution of a missed clinical day, unless the clinical hours already completed are in excess of the 40% clinical and laboratory instruction requirement.

  - i. Jenna Stewart – Committee recommends the application be deferred because the CGFNS report indicates they are unable to provide breakdown of hours for each course because curriculum is integrated and content is not organized in categories using a medical model. Consequently, the CGFNS report does not indicate whether applicant's education is equivalent to someone educated in the United State pursuant to HRS 457-7(f)(2) and HAR 16-89-10(2)

### **Report on Attendance at 2015 NCSBN Midyear Meeting**

The Vice Chair reported that the Chair summed up the meeting very nicely and she did not have anything to add.

### Executive Officer's Report:

#### **Conferences/Seminars/Meetings**

##### 2015 NCSBN APRN Roundtable , April 15, 2015, Chicago, Illinois

The EO reported the Vice Chair will be attending the 2015 NCSBN APRN Roundtable, April 15, 2015 in Chicago, Illinois.

##### NCSBN Virtual Conference – Regulatory Perspectives in Prelicensure Distance Education Program, April 28, 2015, 9:30 a.m. – 4:30 a.m. Central Time.

The EO reported she will try to participate in the virtual conference.

The Vice Chair stated it will be 4:30 a.m. to 10:30 a.m. Hawaii Time.

The Chair stated she will also try to participate.

##### 2015 NCSBN Discipline Case Management Conference, June 1-3, 2015, Indianapolis Indiana

The EO reported Diane Corn, Attorney for the Regulated Industries Complaints Office (“RICO”) will be attending the 2015 NCSBN Discipline Case Management Conference, June 1-2, 2015 in Indianapolis, Indiana.

#### **2014 Legislature – Status Report**

The EO reported on the following bills:

- **HB 354, HD2,SD1/SB 735, SD2 – Relating to Nurses (Continuing Competency Bill)**

This bill requires licensed registered nurses and licensed practical nurses to submit evidence of completed continuing competency requirements prior to the renewal of the license beginning with the July 1, 2017 licensing biennium.

The EO stated HB 354, HD 2, SD 1 was heard yesterday and passed out unamended. It now goes back to the House. SB 735, SD2 is dead.

- **SB 729 – Relating to Advance Practice Registered Nurses**

This bill clarifies the role of advanced practice registered nurses in sections of Hawaii Revised Statutes relating to emergency hospital admission and involuntary hospitalization.

The EO stated this bill was referred to the Judiciary Committee on March 27, 2015.

- **SB 805 – Relating to Health**

This bill removes the sunset provision from Act 255, Session Laws of Hawaii 2012, relating to the definitions of “the practice of nursing as a licensed practical nurse” and “the practice of nursing as a registered nurse”.

The EO stated this bill was referred to the Consumer Protection and Commerce Committee on March 24, 2015.

- **HB 1176 – Relating to Consumer Protection**

The EO stated this bill was the Narcotics Advisory Committee bill. It was then amended to prohibit doctors and podiatrists from prescribing more than three sequential thirty-day prescriptions totaling a ninety-day supply of a schedule II controlled substance. Prohibits refills of a schedule III controlled substance more than five times. This bill however is now dead.

- **SB 807 – Relating to Health**

This bill establishes the narcotics advisory committee to recommend acceptable topics and curriculum for the continuing medical education program. Establishes requirements for a mandatory continuing medical education program for prescribing practitioners that prescribe narcotic drugs.

The EO stated this bill has been deferred.

- **SB 303 – Relating to Health**

This bill establishes the Hawaii drug take-back and education initiative to coordinate and increase the safe return and disposal of drugs and the narcotics enforcement and prescription drug monitoring advisory committee to advise the department of public safety narcotics enforcement division.

The EO stated she is tracking this bill; it was referred to the Finance Committee.

- **HB 253 – Relating to Vaccinations**

This bill authorizes pharmacists to administer vaccines to person between 14 and 17 years of age who have a valid prescription from the patient’s medical home.

The EO stated it previously included APRNs but the way it was written it looked like it expanded the APRNs scope of practice because it did not specify an APRN with prescriptive authority.

Hawaii State  
Center for Nursing:

Ms. Reichhardt stated the Hawaii State Center for Nursing is very excited about the continued competency bill and for the workforce survey coming out later this month.

Correspondence:

**National Council of State Boards of Nursing (NCSBN) – NCSBN Workforce Project**

The Chair stated that NCSBN has developed a system to house, track, and disseminate nursing workforce supply data. Twenty-one boards of nursing currently participate in the system. NCSBN has done this by working directly with licensing vendors to create a tool that will collect the “Nursing Supply Minimum Data Set” in an online licensure renewal process. By participating in this project, Member Boards can view their own state workforce data through reports in NURSUS via Reports at Your Fingertips on a 24/7 basis. NCSBN is currently revising the state reports to include cross-tabular data, separate RN and PN data, and basic workforce data. The ultimate goal is to have all Member Boards participate in order to provide Member Boards and policy makers with nationally aggregated nursing workforce supply data.

The EO stated that Hawaii does not participate with NURSUS in providing nurse licensure data, we only report disciplinary actions. Currently the Hawaii State Center for Nursing (“HSCFN”) conducts a survey of the nurses in conjunction with our nurse renewals.

The Chair stated perhaps we should look into how we could participate and the HSCFN could coordinate with NCSBN.

Ms. Reichhardt stated she recently spoke with Dr. Joanne Specks and she had said she received a workforce data from Montana and California. It was not clean data but that she would be developing a program to clean it. This could be useful to HSCFN.

The EO stated because we do not participate with NURSUS, they would not have a database of nurses to do the survey from Hawaii. The EO asked Ms. Reichhardt if the HSCFN would be willing to share their workforce data with NCSBN?

Ms. Reichhardt stated they would have to determine what their data is and if HSCFN data is comparable, she is certainly willing to speak with them and asked if the information that the Board has today can be shared with her.

The EO stated she will check with NCSBN whether or not she can share the information with HSCFN and get back to Ms. Reichhardt.

### **Off-Label Prescribing by APRNs with Prescriptive Authority**

The Board reviewed an email inquiry asking if per state law, APRNs with prescriptive authority are not permitted to prescribe anything off-label?

After some discussion, and a review of the Hawaii Nursing laws and rules, the Board determined that the current laws and rules do not prohibit an APRN with prescriptive authority to prescribe for off-label use, however, an APRN shall practice within his/her practice specialty, including prescribing of any prescription drug.

Consequently, in accordance with Hawaii Administrative Rules §16-201-90, the above mentioned interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

In addition, the above mentioned informal interpretation applies only to non-controlled substances.
