The Chair called for a motion in regards to the minutes of the June 4, 2015 meeting.

There being no amendments, upon a motion by the Vice Chair, seconded by Ms. Daub, it was voted on and unanimously carried to approve the minutes of the June 4, 2015 meeting as circulated.

2015 NCSBN Annual Meeting, August 19-21, 2015, Chicago, Illinois
The EO reported that the Chair, Vice Chair, Mr. Joslyn and herself will be attending. On August 18, 2015 there is also a Nurse Compact Licensure Administrators meeting that the Chair and Vice Chair will be attending.

<u>2015 NCLEX Conference, September 21, 2015, Portland, Oregon</u> The EO reported that Ms. Daub will be attending.

2015 Legislature – Status Report on Continuing Competency Bill

The EO reported that Act 127 SLH 2015 HB 354, HD2, SD1) was signed into law by the Governor on June 19, 2015. The Board needs to start thinking of ways to educate and inform all nurse licensees. Perhaps begin with a post card mail out and also post the bill and FAQs on the Board's webpage. The Board could also reach out to nursing association and employers. Dr. LeVasseur with the Hawaii State Center for Nursing stated they have begun receiving inquiries on the ambiguous wording of the bill. Licensees are asking if they need to start fulfilling the requirements now.

The Chair stated you start doing the continued competency July 1, 2017. Although we should encourage licensees to do CE's at any time, it is not required that they do it now.

Nursing Renewal – Status Report

The EO reported that renewals have concluded and that approximately 20,000 nurses renewed.

Hawaii State Center for Nursing:

No report.

Correspondence:

APRN Global Signature Authority – Department of Human Services, Med-QUEST forms

The EO stated she received an inquiry from an APRN stating that Department of Human Services (DHS), Med-QUEST would not accept her signature because the form indicates "Physician signature". The EO asked if the Board like to send a letter to DHS asking them to identify the law or administrative rule that allows only a "physician" to sign this form and ask if they can amend what needs to be amended in order to recognize APRNs?

The Board by consensus would like the EO to send out a letter.

DOH Birth Center Law

The Board reviewed an email inquiry about the Department of Health ("DOH") Administrative Rules 11-93-2. Currently, the DOH administrative rules specify a "licensed physician", "suitably qualified license physician", or physician and midwife or nurse", and that it should be replaced with "suitably qualified licensed provider(s)", "licensed provider(s)", or "qualified, and where required, licensed personnel". The email goes on to say "that the idea is that midwives should be able to own, be the medical director and operate a freestanding birth center. Physicians rarely work in birth centers as these are where low risk women birth, and there is no epidurals or ability for controlled substances at these facilities".

The Chair stated they may have an issue with their definition of medical director.

The EO stated their definition of medical director, means a suitably qualified physician who is appointed by the governing body to carryout section 11-93-61.

The Chair stated this doesn't affect nurses.

The EO stated she would like to get the Practice Committee up and running for inquiries such as this one.

The Chair stated this would be appropriate for the Practice Committee.

The EO stated Ms. Kodama, Ms. Kim and Mr. Joslyn will make up the Practice Committee. We will look at meeting in August after the regular Board meeting.

The Chair stated that she would also like to be included in this Committee.

The Board by consensus referred this inquiry to the Practice Committee.

Old Business:

APRN Global Signature Authority – DLIP – Disabilities Compensation Division – Status Report

The EO reported that she had to re-send the letter, as the first one was addressed to the wrong person. However, she has not had any response yet.

The Chair stated this is something that should also be brought to the national board. A lot of the restrictions on practice are federal restrictions based on CMS rules.

RN/LPN Compact and APRN Compact – Status Report

The EO reported that she has samples of how to insert it into the law. She however is still working on it.

The Vice Chair stated they need 26 states to join by 2018 so there's no rush.

The EO stated but if Hawaii joins the compact, wouldn't that cause a lot of nurses to come here, and then our new graduates would not be able to find jobs.

The Chair stated but that means our new graduates could also go to other states to find jobs.

The Vice Chair stated then our graduates could go to other states that do hire new graduates, it would be seamless for them.

The Chair stated she took it upon herself to speak to the head of one of the homecare agencies who was going to start recruiting in Canada because she cannot get homecare nurses here in Hawaii. The Chair told her that there are so many new graduates who cannot find jobs, why are you doing this, and she said, because new graduates cannot be homecare nurses. The Chair then asked her, why not? So she put her in touch with a homecare agency on the mainland that uses new graduates and has a new graduate program. She is now going to work with one of the schools, see about having a mentorship program in their last year for those that are interested in homecare, and she is now going to hire two new graduates.

Ms. Daub stated Hilo Medical Center has cut the new graduate program completely for this year and will not be hiring a single new graduate.

Ms. Kodama stated Maui Memorial is actually cutting staff, but in the past when they have hired new graduates, after they complete their training they quit, so that's why they don't want to hire new graduates.

The DAG asked do they not have an agreement in place that if we train you; you have to stay for a certain amount of time, like 2 or 3 years?

The Vice Chair stated they tried to do that but the unions objected to it.

It was the consensus of the Board to send another letter to Respondent asking her to provide evidence that she is in compliance with or has complied with California Board's August 2007 Stipulated Settlement and Disciplinary Order, case no. 2007-170, and give a deadline for her to respond.

In the Matter of the License to Practice Nursing of **Denise L. Weatherford, RNS 2012-18-L** – Monitor's Report for Period Covering March – June 2015

It was the consensus of the Board to defer acceptance of the monitoring report for period covering March-June 2015, for confirmation that the monitor, Nancy Clare is the Respondent's immediate supervisor at her place of employment.

In the Matter of the License to Practice Nursing of Louis D. Casorla, RNS 2011-39-L Settlement Agreement After Filing of Petition for Disciplinary Action and Board's Final Order.

It was the consensus of the Board to approve the Board's Final Order. In regard to the monitoring requirement, the Board determined that Respondent's monitor shall be his immediate supervisor at his place of employment. If Respondent's immediate supervisor is not a registered nurse or physician, his Director of Nursing shall report any and all complaints and incidents for professional misconduct by or against the Respondent and action taken, if any.
