Old Business:	APRN and APRN with Prescriptive Authority – Revisions to the Applications
	The EO reported that she is working on amendments to the APRN and APRN with Prescriptive Authority applications to simplify and make them easier to understand. It will be a combined application, that way when you apply for APRN, you can also apply for prescriptive authority at the same time. There will however still be a separate application for prescriptive authority. She is also developing a temporary nurse license application separate from the regular license application.
<u>New Business</u> :	The Following Items Were Previously Referred to the Practice Committee by the Board
	The EO asked the Committee to review these items that were previously referred by the Board and determine what needs to be addressed, removed or even consolidated
	 ✓ Nurse Licensure Compact (NLC) ✓ APRN Compact ✓ Criminal Background Checks (CBC)
	Dr. Fleming stated NLC and APRN Compact can be removed since the Board is already addressing this.
	The EO asked if the NLC and APRN Compact is separate?
	Dr. Fleming stated yes.
	The EO stated the Hawaii State Center for Nursing will be introducing a bill next session for NLC and criminal background checks
	✓ Advanced Practice Registered Nurse (APRN) National Certifications
	The EO stated she will be addressing this when she works on the amendments to the applications.
	 ✓ Licensed Practical Nurse – Scope of Practice/Decision Tree ✓ Scope of Practice of Unlicensed Personnel
	The EO stated she has a decision tree from another state that addresses the scope of practice for LPNs and unlicensed personnel that the Committee can used as a template.
	✓ Department of Health - Birth Center Law

The EO stated this is regarding the correspondence the Board received that stated only a physician can be the head of a birthing center.

She is not sure the Board should get involved with this since the Board only has jurisdiction over nurses and not midwives.

Mr. Joslyn stated he thought all midwives were nurses.

Dr. Fleming stated a lot of people think that but that is untrue.

✓ Renewal Requirements for APRN Prescriptive Authority

The EO stated right now they have to do 30 hours of CE's, 8 of which are in pharmacology and also national certification.

- ✓ Regulatory Decision Pathway
- ✓ APRN Scope of Practice

Discussion on this was deferred.

✓ Joint Formulary Advisory Committee – Exclusionary Formulary

The EO stated she has bill drafted to repeal this Committee.

RN National Certification – Case Manager

The EO stated there are at least two disciplinary actions that she knows of going through right now involving case managers that failed to properly care for or monitor the patients care. She is not sure how or whom regulates case managers.

The Chair stated "case manager" is just their title.

✓ Telehealth/Telemedicine

The EO stated part of the Board's duties is to develop and adopt rules as necessary relating to the practice of nursing in telehealth. The Committee will track this and make recommendations to the Board as necessary.

The Committee will continue to review and discuss the items previously referred to the Practice Committee by the Board.
