Call to Order: The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").

There being a quorum present, the Chair called the meeting to order at 9:00 a.m.

Chair's Report: **Announcements and Introductions**

The Chair asked the audience to introduce themselves.

**Additions/Additional Distribution to Agenda**

None.

### **Approval of the Previous Minutes – June 18, 2015**

The Chair called for a motion in regards to the minutes of the June 18, 2015 meeting and stated that on the first page, the DAG for the June meeting was Daniel Jacob.

There being no further discussion or amendments, upon a motion by Dr. Ma, seconded by Ms. Keefe, it was voted on and unanimously carried to approve the minutes for the June 18, 2015 meeting as amended.

Vice Chair's Report: None.

Executive Officer's Report: **HAR Title 16, Chapter 95 – Status Report**

The EO reported the Board members should have received the clean version of the current rules and that based on the Board's previous determination, would like to immediately begin amendments to allow the Board to issue a pharmacy intern permit as early as during their first year of pharmacy school to pharmacy students and to amend §16-95-84 "Transfer of prescriptions." "to include initial prescriptions that may not have been filled. This would allow a pharmacy who has a prescription that may not have been filled, to transfer the prescription to another pharmacy.

There being no further discussion, upon a motion by the Vice Chair, seconded by Ms. Keefe, it was voted on and unanimously carried to move forward with the amendments previously discussed by the Board pertaining to pharmacy intern permits and transfer prescriptions to include initial prescriptions that may not have been filled.

### **Conferences/Seminars/Meetings**

2015 MPJE State Item Pool Review – September 10-11, 2015, Chicago, Illinois – Marcella Chock

Dr. Chock stated that she will be attending the MPJE Standards Setting meeting on August 19, 2015, not the MPJE State Item Pool Review. She is however interested in attending the 2015 MPJE State Item Pool Review as well.

NABP/AACP District 6,7 & 8 Meeting – September 14-17, 2015 Lake Tahoe, Nevada – Mary Jo Keefe

Ms. Keefe stated she will be attending the district meeting and will not be able to attend the Board's September meeting.

### **Emergency Preparedness/State of Emergency**

The EO stated that at the last meeting the Board members were provided the February 2013 "State of Emergency" policy and was asked to review to see if the policy should be updated or amended.

The Chair wanted clarification if “State” of emergency meant the whole state or could a Mayor of a county declare an emergency. She stated that in the past the Big Island experienced “emergency” situations that did not affect the rest of the State, such as the lava flow from the volcano which threatened to destroy some pharmacies and/or blocked roadways so that people could not get to the pharmacy for their medications.

The DAG stated that based on this document and the applicable statute, a state of emergency must be declared by the Governor.

The EO stated that perhaps we should not refer to state of emergency but more of an emergency preparedness policy and that she will review with the DAG and report back to the Board.

### **DME Providers**

The EO asked the Board for clarification on their previous determination based on the definition of “Practice of pharmacy” to require any entity that “dispensed” a prescription device, including durable medical equipment, to obtain a pharmacy license/permit whether located in or out-of-state.

The EO explained that upon review of other definitions, the definition of “drug”, “pharmacy”, “prescription” or “dispensing” did not include “device” but only refers to “drugs”. She also pointed out that there is no definition for “durable medical equipment”, “medical device”, “prescription device” or “device” and that perhaps the Board would need to re-review their laws and rules as there appears to be some concern regarding the who can dispense durable medical equipment.

She asked if any of the pharmacies normally carry “durable medical equipment”? Some of the response from the Board and members of the audience was “no” or that they needed clarification on what exactly is “durable medical equipment”.

Mr. Smith stated regardless if there are drugs, you could actually hurt someone if you don’t tell them how to use that product. The issue is, do we want to as pharmacist, give away our expertise or whoever is the expert on that product. There may be some non-pharmacies that do have training and do train the patient on the device, but where is the over-sight on what kind of training they have? There should be concern over the dispensing of any prescription device since the FDA determined that a prescription is required for that device.

The EO stated that when the Board previously determined that only pharmacies may dispense any prescription drug or device, that this was part of their concern as well.

She stated, however, that the Board has to weigh the patient safety issue versus the access to durable medical equipment for residents of this State.

Executive Session: At 9:33 a.m., upon a motion by the Vice Chair, seconded by Dr. Chock, it was voted on and unanimously carried to move into executive session pursuant to §92-5(a)(4), HRS, "To consult with the Board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities;".

At 11:30 a.m. upon a motion by Ms. Keefe, seconded by Dr. Chock, it was voted on and unanimously carried to move out of executive session.

Chapter 91, HRS, Adjudicatory Matters: The Chair called for a recess from the meeting at 11:30 a.m. to discuss and deliberate on the following adjudicatory matter(s) pursuant to Chapter 91, HRS:

In the Matter of the Pharmacist's License of **David A. Kanak; PHA 2012-18-L**, Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order; Exhibit "1"

Upon a motion by Dr. Chock, seconded by Ms. Keefe, it was voted on and unanimously carried to approve the Board's Final Order.

Following the Board's review, deliberation, and decisions in this matter, pursuant to Chapter 91, HRS, the Chair announced that the Board was reconvening its scheduled meeting at 11:32 a.m.

Executive Officer's Report:

#### **DME Providers**

The Chair stated that although there is concern with patient safety with the use of certain devices, the Board has not been presented with evidence of harm related to current operating DME providers.

She stated that it is also the understanding that DME providers must obtain DMEPOS accreditation to become a Medicare DMEPOS provider in order to bill certain items to Medicare and that the accreditation process involves providing evidence of personnel training, recordkeeping and training on the use of devices to the patient and evidence of the patient's understanding of use.

Therefore, in order to improve access to devices that do not contain prescription drugs or devices used for the delivery of prescription drugs, the Board will only require a pharmacy license or miscellaneous permit for entities dispensing devices that contain prescription drugs and/or devices used for the delivery of prescription drugs.

The Board will continue to explore possible oversight of DME providers.

The Board agreed.

This is an informal interpretation in accordance with Hawaii Administrative Rules section 16-201-90 for informational and explanatory purposes only. It is not an official opinion or decision and is thus, not binding on the Board.

## **Immunization of Minors**

### Immunization Training for Pharmacist Administering Vaccines to Minors – 15 Hours Acceptable?

The EO stated that when the bill initially passed the Board heard from the Hawaii Pharmacists Association (HPhA) when discussing the immunization training course required to administer the influenza vaccine to minors. At that time, based on the information provided, the Board accepted the 20 hour immunization course.

At the June 18, 2015 meeting, the Board discussed only accepting ACPE courses for the renewal training requirement to immunize minors as long as it was at least one hour.

The EO stated that they received a Certificate of Completion from a pharmacist who completed an immunization course presented by the Washington State Pharmacy Association in 2008, but the information the pharmacist provided on the course is current (2015) and not necessarily from the 2008 program. It indicates the course as being fifteen (15) hours and is ACPE accredited.

After some discussion, it was the consensus of the Board to accept any ACPE approved immunization program for the initial and renewal training requirements.

### FAQs for Immunization of Minors

The Board reviewed a draft of FAQs to be posted on the Board's web page.

There were no concerns expressed by the Board members.

**Are Out-of-State Pharmacies Permitted by the Board Required to Comply with Hawaii Pharmacy Laws/Rules?**

The Board reviewed an inquiry from Laurel Wala, Esq. on behalf of her client who is a compounding pharmacy located in California asking if her client, who becomes registered as a non-resident pharmacy in Hawaii is required to comply with the laws of its home state pursuant to HRS 461-15(a)(7)(C) or are there Hawaii pharmacy statutes and regulations that they must comply with.

The Vice Chair stated that the application for a miscellaneous permit states that they have to comply with Hawaii pharmacy laws.

The EO stated that she could not find an actual section that made that requirement and that she remembers that previously another DAG had concerns with the Board requiring an out-of-state entity or individual to comply with Hawaii statutes if they were not practicing in this State.

The DAG stated it would be difficult to enforce.

After some discussion, it was the consensus of the Board to defer this for further discussion/consideration after a more thorough review of the pharmacy laws and rules can be conducted by the Laws and Rules Committee and consultation with Mr. Edwards of the DOH and Keith Kamita, Administrator for the Department of Public Safety, Narcotics Enforcement Division.

### **Are Hawaii Pharmacies Permitted to Purchase Genetic Tests from Laboratories?**

The Board reviewed an inquiry from Emily Johnson, Attorney, asking if Hawaii pharmacies are permitted to purchase genetic tests from laboratories and if so, are they allowed to markup the cost to the patient.

The Chair stated that there may be two (2) types of “tests”, home tests or test that you can take at home such as a pregnancy test or a physician ordered test, but from the email it is unclear as to which type of tests she is referring to.

Ms. Keefe stated that under the definition of “Practice of pharmacy” in HRS 461-1, the practice of pharmacy includes, “Ordering drug therapy related laboratory tests;”.

The Chair added this section pertains to procedures or functions that would require a collaborative agreement.

After some discussion, it was the consensus of the Board to inform Ms. Johnson that Hawaii pharmacists (not pharmacies) may “Order drug therapy related laboratory tests;” pursuant to the definition of “Practice of pharmacy” under HRS 461-1 but that the Board does not have the authority to address the appropriateness over the pricing of such tests.

### **Request for “Guidance” on the Responsibility of the Pharmacist When Only Medical Devices Classified as “Legend Devices” Will Be Sold**

The Board directed the EO to respond to this inquiry based on their previous discussion and informal interpretation regarding DME providers.

### **Theft Reporting**

The Board discussed the concern over pharmacy robberies.

Dr. Ma stated that upon review of the security requirements in the law it only ask for a “description” of the security measures and does not include any specific requirements.

The EO expressed concerns that some retail stores with pharmacies are open twenty-four hours which may include the pharmacy, which makes the pharmacy staff more vulnerable.

After some discussion, it was the consensus of the Board to refer this to their Laws and Rules Committee for research other state regulations to see if this is addressed or if security measures should be specified in the pharmacy laws/rules.

It was the consensus of the Board to refer the course information to the Regulated Industries Complaints Office for their consideration and/or appropriate action.
