#### b. Prometric Exam Fees

c. Introduction of New Board Member

The Executive Officer introduced the Board's new public member, Scott Ai. Mr. Ai is the Vice President of Estimating at Beachside Roofing, LLC and brings experience from several specialty contracting disciplines. He worked in the construction industry for over twenty-five years in both Hawaii and California.

- d. - b. Executive Officer announced that Association of Structural Pest Control Regulatory Officials (ASPCRO) 60<sup>th</sup> Annual Meeting will be held August 23-26 2016, in Santa Fe, New Mexico. The Department will cover the costs for one Board member to attend the meeting.
- c. The Executive Officer reminded the members that Vice Chairperson Rodney Ono's term will expire on June 30, 2016, and that there will be a vacancy. Individuals interested in serving on the Board should file an application with the Governor's Boards and Commissions Office as soon as possible.
- d. DAG Tam indicated that there is, in process, a letter to the Department of Agriculture, Pesticides Branch, which clarifies the responsibility for the approval of Non-Chemical Pest Control Devices (NCPCDs) and for the determination on whether a device is a NCPCD.
- e. Executive Officer Ferrer stated that quorum has been affected lately, primarily due to reasons beyond the control of two Board members. She indicated that letters will be sent to the Hawaii Department of Health (HDOH) and the Hawaii Department of Plant and Environmental Protection Sciences (PEPS) to request that they designate alternate representatives to serve in the absence of the current ex-officio members of the Board.
