### **Approval of the Previous Minutes – April 7, 2016**

The Chair called for a motion in regards to the minutes of the April 7, 2016 meeting.

There being no discussion, upon a motion by the Vice Chair, seconded by Ms. Daub, it was voted on and unanimously carried to approve the minutes of the April 7, 2016 meeting as circulated.

Report of April 7, 2016 Practice Ms. Kodama reported on the following:

Committee Meeting:

Continuing Competency

1. Continuing Education
  - Home study courses available – Committee developing list of approved CE providers
  - CE courses approved by other state boards of nursing – Committee developing list of approved CE providers
  - Additional information regarding Swank Healthcare – Committee determined that Swank Healthcare's courses from the Texas Tech University Health Sciences Center School of Nursing Continuing Nursing Education Program is accredited as a provider of continuing education by the American Nurses Credentialing Center's Commission on Accreditation (ANCC) and that they should be included on the list of approved providers
  - The EO will prepare a draft of a list of approved CE providers for the Committee's consideration at the June meeting.
2. Refresher Courses
  - Maui Community College – The EO will contact Maui Community College to see if they have a refresher course
3. 2 Semester Credits of Post-licensure Courses
  - Maui Community College – The Committee determined that 2 semester credits of a post-licensure nursing program, i.e. ADN – BSN would be acceptable

8. APRN Scope of Practice – Committee will be discussing at June meeting.
9. Joint Formulary Advisory Committee – Exclusionary Formulary – There is a bill moving through the Legislature that will repeal the JFAC.
10. Home Health Care – Deferred for now.

11. Telehealth/Telemedicine – Deferred for now.
12. APRN Compact – Deferred for now.

Upon a motion by Mr. Joslyn, seconded by the Vice Chair, it was voted on and unanimously carried to approve the Practice Committee's report and recommendations.

**2016 Legislature – Status Report**

The EO reported on the following bills:

HB 2331, HD1 (Act 8, SLH 2016) - Relating to Board Member Terms for the Board of Nursing

This bill was signed into law that would extend the terms of the Board of Nursing members from 3 to 4 years.

The EO stated that she will be sending a letter to the Governor's Office confirming the terms of all the current Board members.

SB 2861, SD2, HD1 – Relating to the Joint Formulary Advisory Committee

This bill was enrolled to the Governor's Office on May 3, 2016 that would repeal the Joint Formulary Advisory Committee ("JFAC").

The EO stated that she will be including additional amendments to the current draft she is working on to HAR Chapter 89 to delete any reference to the JFAC.

SB 2862 (4/8/16 Enrolled to Governor) – Relating to Nursing (Nursys)

This bill was signed into law that allows the Board to “fully” participate in Nursys.

The EO stated that she will be contacting NCSBN to let them know and to see what steps need to be done to implement this program including any application changes and procedures by our Licensing Branch.

SB 2672, SD1, HD1 – Relating to Advanced Practice Registered Nurses

This bill passed final reading and should hopefully be enrolled to the Governor’s Office where the Governor can approve or veto.

HB 1756, HD3, SD2 – Relating to Nursing (Criminal Background Checks)

This bill also passed final reading and should hopefully be enrolled to the Governor’s Office where the Governor can approve or veto.

The Chair asked if we knew whether the Governor was going to approve the APRN and CBC bills.

Ms. Reichhardt stated that she spoke with Kelly Rose and Senator Baker yesterday, and it appears that they feel it has a very positive path forward.

HB 2707, HD1, SD2, CD1 – Relating to Medical Marijuana

This bill also passed final reading and should be hopefully enrolled to the Governor’s Office.

The EO stated that this bill would allow APRNs with prescriptive authority to qualify patients for medical marijuana.

**Amendments to Title 16, Chapter 89 – Status Report**

The EO reported that she will start working on this now that the Legislative Session is over.

**Continuing Competency Program**

Inquiry in HRS §457-9.3 Learning activity options – “Completion of a minimum of two semester credits of post-licensure academic education related to nursing practice from an accredited nursing program;”

The Board reviewed and discussed a request from Patricia Nishimoto, an oncology CNS asking that the Board consider amending the above mentioned learning activity by deleting reference to “nursing” in reference to “related to nursing practice”.

Ms. Nishimoto explains in her letter that being an oncology CNS, she takes courses in thanatology because it pertains to her nursing practice.

The Chair stated it does not say “directly” related to nursing practice, it says related. If you remove “nursing” from that statement, then it could be related to anything.

The EO asked what thanatology is?

The Chair replied it is the study of death.

The EO asked if that could be related to nursing?

The Chair stated yes, it could be related.

Ms. Kodama stated as long as they can show what the relation to nursing is.

After some discussion and careful consideration, it was the consensus of the Board that the learning activity mentioned above may be interpreted broadly allowing nurses to take courses that “relate” to their nursing practice.

If the course is not provided by an accredited nursing program, the Board has the option of considering the learning activity on a case by case basis pursuant to HRS 457-9.3(10).

The Board also referred this inquiry to the Practice Committee.

#### Nurses Continuing Education

The Board reviewed and discussed the following questions from Sofia Pyzyk of World Continuing Education Alliance:

1. Does the board accredit CE courses online?
2. Does the board accept CME credits?
3. Are licensees required to give feedback on the CE course they've taken?
4. What is the minimum length of a course that you'll approve? i.e. less than 30 minutes don't count?
5. Are licensee required to take a CE course post-test? If so what is the pass rate? How many attempts are allowed?
6. Does the certificate of completion require a provider signature in order to be approved?

After some discussion, it was the consensus of the Board to reply as follows:

In response to the inquiry regarding “Thirty contact hours of continuing education activities,” pursuant to HRS 457-9.3 Learning activity options.:

- The Board will be coming out with a list of approved providers of continuing education courses, whether the provider offers the course(s) online or live or offers CME credits;

- As for providing “feedback” or taking a post-test, the law does not specifically require this;
- There are no requirements for the length of the course as long as the nurse licensee completes a total of 30 hours;
- In regards to the signature of the provider on the completion certificate, the Board will be working on what kind of documentation would be acceptable.

In addition, the Board’s Practice Committee is working on developing a list of training topics or courses that may NOT be considered to meet the CE requirement.

NLN Connecticut League for Nursing 100% online RN Refresher Course

The Board reviewed information from the NLN Connecticut League for Nursing’s 100% online refresher course to see if it would qualify as a “refresher” course for one of the continuing competency learning activity options.

The EO reported that previously, the Board accepted this online refresher course for nurses who have not practiced for at least 5 years but wanted to reactivate their Hawaii nurse license pursuant to HRS §457-9(b). The Board recognized this course as meeting both the didactic and clinical components. However, the Board reconsidered this online course and determined that it would only meet the didactic component of a “refresher” course to reactivate a nurse license.

After some discussion, it was the consensus of the Board that this course may satisfy the didactic component of a “refresher” course only and that this matter should be referred to the Practice Committee to determine if any definitions need to be amended or added to clarify terminology as used in HRS 457-9.2 and 9.3.

**Fee Increase – Previously Discussed at March 5, 2015 Meeting**

The EO reported the fee increase is in its final stages so the Department wants to make sure the word gets out as much as possible. This notice is also posted on the Department’s webpage.

Hawaii State  
Center for Nursing:

Ms. Reichhardt reported she received an email regarding a nurse from another state who will be traveling to Hawaii with a student that she cares for, and she wanted to know how that would work. She said she will forward that email onto to the EO.

Related to continued competency, the HSCFN has a group that organizes precepting activities and they are going to create a baseline of what is happening in the state and provide that information to the Board. They will also be coming up with a recommendation to the Board for their consideration regarding nurse

researchers and nurses who do evidence based practices about that requirement for continued competency. Ms. Reichhardt also stated she is working on some updates regarding travel nursing, although the response rate to the survey has been quite low, less than 50% response rate for travel nursing and agency nursing, they would like to go for a mandatory survey for the most accurate data.

The Chair stated the issue of having a mandatory survey has come up before and this Board has already said that is not going to happen.

The EO stated you cannot make the survey part of their license requirement.

The Chair stated you would probably get more information regarding the travel nurses from the employers.

Ms. Reichhardt stated they will also have information regarding the access model related to the ADN to BSN academic progression question. The last thing was their APRN Practice and Policy Committee met on Tuesday and they will begin working on a video series about the value of nursing and who you are as a nurse.

Ms. Reichhardt stated she will not be able to attend the Board's June meeting but will send a representative from HSCFN in her place.

The EO asked Ms. Reichhardt if the HSCFN belongs to the National Organization for Center's for Nursing?

Ms. Reichhardt stated yes, it's called the National Forum for Nursing Workforce Centers.

Correspondence:

**CRNA Working With a Podiatrist**

The Board reviewed an inquiry from Jennifer Stike, Regional Medical Staff Services Director for Kona Community Hospital & Kohala Hospital on whether an independent CRNA can work with a Podiatrist.

After some discussion, it was the consensus of the Board that the nurse practice act does not prohibit a CRNA from working with another practitioner. A CRNA may practice in this State as long as the CRNA is appropriately licensed and is practicing within his/her scope of practice including but not limited to HRS §457-2.7 and HAR §16-89-81 and the NCSBN Model Nursing Practice Act and Model Nursing Administrative Rules.



### **APRN Performing Minor Surgery**

The Board reviewed an inquiry from Dr. Gary Okamoto on APRNs performing “minor surgery”. Dr. Okamoto explained “minor surgery” as low risk; quick results and healing; can be performed safely in non-hospital based clinic or office, does not require general anesthesia or procedural sedation & analgesia; and local anesthesia may be applied. He also referred to examples such as decompressing a boil, removing foreign body, excising a wart, ear piercing, ingrown toenail and debriding a dirty abrasion.

The Board discussed whether the acts mentioned by Dr. Okamoto were in fact procedures rather than “minor surgery” and that the nurse practice act does not define “minor surgery”.

HAR §16-89-81 includes “assist in surgery” under the APRN practice, however, does not specifically allow an APRN to perform “minor surgery”.

The Board also considered other factors such as the facility’s written policies and procedures and reimbursement (if the procedures mentioned above were coded by an insurance carrier as “minor surgery”).

After some discussion, it was the consensus of the Board that pursuant to the following sections, an APRN may perform activities within their practice specialty for which they have received the appropriate education and training for:

**[§457-1.5] Practice of nursing.** (a) Nursing is a scientific process founded on a body of professional knowledge. It is a learned profession based on an understanding of the human condition across the lifespan of a client and the relationship of a client with others and within the environment. It is also an art dedicated to caring for others. The practice of nursing means assisting clients in attaining or maintaining optimal health, implementing a strategy of care to accomplish defined goals within the context of a client-centered health care plan, and evaluating responses to nursing care and treatment. Nursing is a dynamic discipline that is continually evolving to include more sophisticated knowledge, technologies, and client care activities. Nursing applies evidence-based practice to promote optimal client outcomes.

(b) The scope of nursing practices established in this chapter and by the rules of the board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting.

**§457-2.7 Advanced practice registered nurse.** (a) Practice as an advanced practice registered nurse means the scope of nursing in a category approved by the board, regardless of compensation or personal profit, and includes the registered nurse scope of practice. The scope of an advanced

practice registered nurse includes but is not limited to advanced assessment; telehealth; and the diagnosis, prescription, selection, and administration of therapeutic measures including over the counter drugs, legend drugs, and controlled substances within the advanced practice registered nurse's role and specialty-appropriate education and certification.

(b) The advanced practice registered nurse's scope of practice supersedes the registered nurse's scope of practice. Advanced practice registered nurses shall practice within standards established or recognized by the board and be guided by the scope of practice authorized by this chapter, the rules of the board, and nursing standards established or recognized by the board including but not limited to:

- (1) The National Council of State Boards of Nursing Model Nursing Practice Act, Article II, Scope of Nursing Practice, section 4; and
- (2) The National Council of State Boards of Nursing Model Nursing Administrative Rules, Chapter Two, Standards of Nursing Practice, section 2.4.1;

provided that NCSBN shall have no legal authority over the board and shall have no legal authority or powers of oversight of the board in the exercise of its powers and duties authorized by law.

(c) An advanced practice registered nurse shall comply with the requirements of this chapter; recognize limits of the advanced practice registered nurse's knowledge and experience and planning for the management of situations that exceed the scope of authorized practice; and consult with or refer clients to other health care providers, as appropriate.
