<u>Call to Order</u>: There being a quorum established, Chairperson Tsuchiyama called the

meeting to order at 1:03 p.m.

Approval of It was moved by Dr. Corcoran, seconded by Dr. Kroll, and

the Minutes: unanimously carried to approve the minutes of December 3, 2015

<u>Chair's Report:</u> Chair Tsuchiyama thanked everyone for working on rule revisions and

getting it done in a timely manner.

Executive Officer's

Report: Executive Officer Kramer introduced the 2016 legislative bills affecting

acupuncture, and also asked for a volunteer to be the legislative delegate representing the Board should testimony be required to be presented. Chair Tsuchiyama volunteered and Dr. Kroll will be the backup as long as she can still testify as an individual as well as on behalf of the Board.

DAG Tam says as long as she specifies to the Legislature that she may be testifying for the Board as well as an individual.

Bills that were introduced to the Board:

- 1. H.B. 1062 General Excise Tax; Medical Services Exempts medical services from the general excise tax.
- 2. H.B. No. 419 General Excise Tax; Food and Medical Services Provides a general excise tax exemption for food after December 31, 2019, and for medical services after December 31, 2017.
- 3. H.B. No. 1922 General Excise Tax; Food and Medical Services; Housing

Provides a general excise tax exemption for food after December 31, 2020, for medical services after December 31, 2018, and rental subsidy payments for section 8, Housing First, and other related low-income housing programs after December 31, 2018.

4. S.B. No. 3041 - Health Care Professionals; Continuing Medical Education

Requires health care professionals to take a continuing medical education course in health issues unique to Hawaii. Requires the DOH to develop the course, in consultation with the Hawaii Medical Board.

The hearing for this bill was set for Friday February 5, 2016 at 9:00 a.m.

Comments on S.B. No. 3041

Dr. Corcoran stated that acupuncture renewals don't require continuing education like other areas and doesn't think bill is overly burdensome. Dr. Kroll stated the Board is bound by its rules.

Chairperson Tsuchiyama said, as a practitioner, she is an advocate for CEUs, to keep up with current events.

Questions that were brought up:

- 1. How many and/or which states require NCCAOM certification?
- 2. How many states are thinking about it?

The Board agrees that it supports the intent of the bill, but is unable to implement. So, will defer to DCCA.

Dr. Kroll mentioned 2 bills affecting acupuncture practitioners, but not the licensing law: S.B. No. 1178 which increases the authorized benefit for acupuncture treatments allowed under

personal injury protection benefits provided through motor vehicle insurance, and S.B. 1034 which increases the authorized benefit for naturopathic, chiropractic, and acupuncture treatments allowed under personal injury protection benefits provided through motor vehicle insurance.
