Executive Officer's Report

Executive Officer Rutkowski reported that electricians who renewed online and failed to submit the requisite continued competency information were informed that they have until August 12, 2014 to submit the information. If there is no response, the renewal fee will be refunded

and they must restore their licenses within the year.

Executive Officer Rutkowski introduced May Ferrer and Carol Kramer, new executive officers who are auditing the board meetings as part of their orientation.

Vice Chairperson Akamu announced he was taking the agenda out of order to address item #9 on the agenda, Unfinished Business.

<u>Unfinished</u>

Business:

a. <u>Proposed Rule Revisions - HAR Title 16 Chapter 80, "Electrical Work" as pertains to Photovoltaic installations.</u>

Executive Officer Rutkowski informed the Board and guests that since October 2013, the Board has been soliciting feedback from the public and since April 2014 the Board's interpretation has been posted on the Board's website. At the May 2014 Board meeting, the Board received Solar City's suggested rule draft change language and was assured by Solar City that there will be more contributions from the industry. No additional rule change suggestions have been received as of the last Board meeting. Mr. Yoshimura, from Solar City, asked the Board for a deadline to turn in the language for rule change because the industry is currently concentrating on HECO's proposed changes to the PUC this month. Executive Officer Rutkowski responded that there is

no deadline except that if language is received early then the changes can be drafted.

DAG Tam added that the Board is looking for specific language for rule change. The Board's position as stated on the Board's website will probably be inserted into the rules verbatim.

New Business: a. Continued Competency – UPC Updates for 2015 Plumber's License Renewals

Executive Officer Rutkowski reported to the Board that the Honolulu Community College informed her that they were ready to mail out information to the licensed plumbers that the continued competency classes were ready for the June 30, 2015 renewal. The Board was never informed that a CE course was created and has not approved this course for the 2015 renewal.

Mr. McDermott stated that he created the 2009, 2011 and 2014 CE classes for the plumbers and never knew that the Board approved the courses. He said Preshess Willets Aguilar organized everything and since she left he was never notified about creating another class. He took it upon himself to start the process because renewal is next year. He also stated that normally a new CE course is not created unless there are significant changes to the UPC. He handed out the syllabus of the CE course to the Board members and informed them that the State will adopt the 2012 UPC.

Executive Officer Rutkowski stated the Building Trades Council has approved moving to adopt the 2012 UPC and 2014 NEC. Mr. Hiraki stated that it is important that the counties adopt the same updates because the county inspectors follow the updates adopted by the counties. Mr. McDermott responded that he just had 9 plumbing inspectors attend his class. Mr. Serikaku added that UPC updates must be adopted in their rules within 6 months of publication and that some updates have been sitting at the Building Trades Council for months mainly because updates are adopted only if there are significant changes. He also added that the counties have 2 years to adopt the updates.

After further discussion, the Board reviewed the syllabus on the CE course on the 2012 UPC distributed by Mr. McDermott and found the course to be comprehensive. It was moved by Mr. Hiraki, seconded by Mr. Brady, and unanimously carried to approve the syllabus of the Honolulu Community College July 2014 Plumbing Continued Competency Program covering the changes in the 2012 UPC.

Mr. Ta'a thanked Mr. McDermott for all his work in putting together these courses to ensure that the public is protected.

Executive Office Rutkowski requested the two plumbing Board members meet with Prometric to do item writing for the plumbing update exam and Mr. McDermott is also welcome to attend the meeting with Prometric.

Vice Chairperson Akamu announced he was resuming the order of the agenda.
