Once Dr. Curry submits evidence to the Board that he is authorized to work in the U.S., has met all the licensing requirements in effect at that time (including, but not limited to, the requirement that he has not been convicted of any crime that is directly related to the profession or been disciplined in any jurisdiction in which he holds a medical license), and provides his U.S. Social Security Number, the Board may issue Dr. Curry a license.

This conditional approval is valid for two (2) years. If Dr. Curry is unable to provide the information and meet the requirements by the end of the time period, Dr. Curry may be required to reapply for a license and meet all of the requirements in effect at that time.
