This form is being sent for you to acknowledge the relationship of the detective or guard firm/agency and the "Responsible or Subordinate Principal Detective or Guard" of the detective or guard firm/agency.

The "*Responsible principal detective or guard*" is one who is employed by the detective or guard firm/agency and who qualified the detective or guard firm/agency for licensure.

An agency may employ more than one principal provided the firm/agency designates a "Responsible" principal who shall be primarily responsible for the direct management and control of the firm/agency's employees and shall be held responsible for the acts of those employees while they are acting within the scope and purpose of the detective or guard firm/agency's business.

Other principals employed but not designated by the firm as the responsible principal shall be referred to as subordinate principals and shall be responsible for specified activities related to the license held.

Your attention is directed to sections 16-97-2 and 16-97-7 of the rules of the Board of Private Detectives and Guards. Failure of the "*Responsible or Subordinate Principal Detective or Guard*" to comply with Chapter 463, Hawaii Revised Statutes or of Chapter 16-97, Hawaii Administrative Rules, may result in disciplinary action including fines, and the suspension or revocation of the licenses of both the responsible or subordinate principal detective/guard and the firm/agency.
