It was moved by Chief Perry, seconded by Vice Chairperson Galas and unanimously carried to defer the above application pending receipt of letters of recommendation from the community attesting to a firm belief that the applicant has been sufficiently rehabilitated.

g. Guard Employee Ratification

It was moved by Chief Perry, seconded by Mr. Chang, and unanimously carried to **ratify** the approval of the Guard Employees assigned registration numbers GDE-9943–10598 (see the attached list).

h. Waiver/Personal Appearance for Oral Interview

- 1) Eyleen McCluskey-Shouman (PD)
Sole

The Board reviewed Ms. McClusky-Shouman's email request to waive her personal appearance before the Board for her private detective license and asks whether the interview can be done via phone, Skype, or something similar that does not require her to travel to Honolulu.

After some discussion it was moved by Vice Chairperson Galas, seconded by Mr. Chang, and unanimously carried to deny the request pursuant to Hawaii Administrative Rules ("**HAR**") section 16-97-26(d), which provides in relevant part that:

- "(d) The applicant for a private detective or guard license shall take and pass an examination and personally appear before the board for an oral review concerning the applicant's application. The principal for any agency shall appear before the board for an oral review concerning the agency's application which is under consideration for a license. Based upon the oral review and other information which is before the board, the board may grant or deny the application for license." (Emphasis added)

The Board determined that the language above requires the personal appearance of the principal detective before the Board.

The Board further determined that HAR section 16-97-26(e) only provides a waiver for any partner, member, manager, or corporate officer who has previously appeared before the Board or where their appearance is a hardship due to travel from out-of-state. Similar waiver language is not found in HAR section 16-97-26(d) that applies to the principal of a guard or detective agency.

Executive Officer's Report:

a. Guard Employee Registration Statistics

b. Guard Employee Online Registration

Executive Officer Tamanaha reported that the department is currently working with Hawaii Information Consortium ("HIC") on developing an online registration process for guard employees. The piece currently being worked out is the criminal history records and how the Board can retrieve the records electronically. Once this is resolved the first online registration may be available.

c. CJDC Audit

Executive Officer Tamanaha informed the Board that she is currently reviewing and writing procedures to be in compliance with the CJDC audit. The Ecrim report is public record but the FBI report is confidential, cannot be shared even with the applicant and must be stored in a secure location. The Board will be apprised of the outcome.

Act 208 (SLH 2010)
and Any Matters
Relating to its
Implementation:

a. Initial 8 Hour Security Guard Training Curricula

- (i) United Armored Car Services Initial 8 Hour Security Guard Training Curricula

It was moved by Vice Chairperson Galas, seconded by Mr. Chang and unanimously carried to approve the United Armored Car Services Initial 8 Hour Security Guard Training Curricula pending receipt of a corrected version of the Professional Appearance and Aloha Training section.

b. Scope

- (i) Request for Board determination if Adult Corrections Officers (ACOs) are required to comply with Act 208 (SLH 2010) if they are employed as guards outside of the prison system.

After some discussion, it was moved by Vice Chairperson Galas, seconded by Mr. Akiona and unanimously carried that ACOs are only subject to the requirements of Act 208 (SLH 2010) if they are working as a guard outside of their regular employment with the prison system.

- (ii) Request for Board determination if Traffic Controllers are required to comply with Act 208 (SLH 2010).

The Board reviewed the inquiry regarding whether Aloha Security Traffic Controllers are subject to the registration requirements of Act 208 (SLH 2010) according to the following job description provided:

“They monitor the flow of traffic at designated job sites, being alert for inattentive motorists. They help to direct

traffic in a safe manner to protect our clients while working and to protect their vehicles, property and equipment at all times.”

The definition of a “guard” in HRS section 463-1 is as follows:

“Guard” means a registered uniformed or nonuniformed person responsible for the safekeeping of a client's properties and persons within contractually prescribed boundaries, and for observation and reporting relative to such safekeeping. “Guard” shall not include any active duty federal, state, or county law enforcement officers or personnel.”

Based solely on the information provided, the Board determined that an Aloha Security Traffic Controller falls within the definition of a “guard”, and is therefore subject to the registration requirements of Act 208 and HRS chapter 463.

- (iii) Request for Board determination if Airport Firefighters are exempt from providing the proof of high school education requirement for Act 208, (SLH 2010).

After some discussion, it was moved by Chief Perry, seconded by Mr. Chang to deny Airport Firefighters from providing proof of an exemption for a high school education since the Department of Human Resource Development indicated that a high school diploma or its equivalent is not required for the Airport Firefighter position.

- c. Email to Chief Perry requesting Board approval of badge used by Marriott Vacations Club/Kauai Lagoons.

The Board reviewed the photo of the Kauai Lagoons Security badge provided in the email. After further discussion, it was moved by Vice Chairperson Galas, seconded by Chief Perry, and unanimously carried to approve the badge as it does not resemble badges used by Law Enforcement agencies within the State.

2014 Board
Renewals:

- a. Update

The Professional Vocational Licensing division is currently working on the ability to restore guard employee registrations online. Guard employees have one year to restore by paying a penalty

fee. Employers will be able to use their subscriber accounts to assist in the restoration of the employee's guard registration. The target date of the online restoration is mid September.

Open Forum: a. Mr. Chang asked the Board to confirm his understanding of OJT training pursuant to HRS Chapter 463-10.5(c).

“Guards and individuals acting in a guard capacity shall successfully complete the classroom instruction specified by this section, pass a written test, and undergo four hours of on-the-job training supervised by an individual who has successfully completed all of the requirements of this section or who has otherwise been approved by the board for on-the-job training....”

The consensus was that OJT may last as long as is required for training in addition to the requisite 4 hours and that these trainees must be under the supervision of a registered guard employee. The Board further indicated that a trainee should not be in uniform as it would appear that the trainee is “acting in a guard capacity”. These employees should also not be counted to meet contract requirements as they are not registered. The Board recommended trainees be clearly distinguishable from registered guards under whom they are being trained.
