b. Scope

(i) Email inquiry asking if active duty DOD police officers working part-time for a guard agency are subject to the requirements of Act 208 (SLH 2010).

The Board reviewed the inquiry asking if active duty DOD police officers working part-time for a guard agency are subject to the requirements of Act 208 (SLH 2010). Mr. Chang commented that the DOD police officers only have jurisdiction on federal property and they do not have 24/7 capabilities. DAG Tam added that if a DOD police officer is working part-time outside on non-federal property then they are still subject to the requirements of Act 208 (SLH 2010).

After further discussion, it was moved by Mr. Chang, seconded by Chief Perry and unanimously carried based upon the information provided, that DOD police officers are not subject to the guard registration requirements of Act 208 (SLH 2010) or HRS Chapter 463 while they are working in their capacity as a DOD police officers; however, these DOD police officers are subject to Act 208 (SLH 2010) and HRS Chapter 463 when they act as guards outside of their employment with DOD.
