1. He shall submit an annual FBI national criminal history record check and State of Hawaii criminal history record check from the Hawaii Criminal Justice Data Center ("criminal abstracts") to the Board.
  - a. These criminal abstracts shall be due on January 31 of each year and shall cover the periods of January to December.
  - b. In order to obtain these criminal abstracts, he shall be fingerprinted electronically at Fieldprint, Inc. at the applicant's expense; and
2. He shall refrain from any actions that may result in his arrest or conviction for any crimes against persons or property (including but not limited to theft, burglary, assault, etc.) or any other act that is directly related to the guard profession.
  - a. He shall report any such arrests or convictions to the Board within thirty (30) calendar days of the arrests or convictions; and
  - b. If he fails to timely notify the Board of such arrests or convictions, this conditional registration shall be automatically revoked without a hearing on the 30th day after the date of the arrests or convictions.

It was moved by Chief Perry, seconded by Vice Chairperson Galas and unanimously carried to deny the following guard employee registration application for failure to satisfy the registration requirements of HRS chapter 463-10.5.

a. Initial 8 Hour Security Guard Training Curricula

- 1) Classroom Definition (Deferred from the April 16, 2015 meeting.)

Vice Chairperson Galas provided the Board with an Executive Summary of his findings that described the primary purpose of distance learning at the University of Hawaii's ten campuses is to extend the University's rich array of quality instructional resources to students anywhere in the state who are committed to higher education but are constrained by diverse factors which prevent their participation as regular on-campus students at the University of Hawaii campuses. In addition, distance learning was described as providing students with access to education through a network of various technologies and instructor and students interact at a distance without having to be physically present in the same location <http://www.hawaii.edu/dl/pswhatistdistancelearning>

The Executive Officer stated that Ms. Willetts Vaquilar could not find a definition of a classroom and therefore the Board could define "classroom" in the rules. DAG Tam added that as there is no clear definition of "classroom" used by the University of Hawaii system, the Board should consider defining the term in its rules. The Executive Officer informed the Board that David Heaukulani will be informed that the Board is still contemplating this issue.

Vice Chairperson Galas recommended that members review his findings and further discuss this matter at a subsequent meeting. If parameters are set to insure interactive classes, allowing distance learning is feasible and worth consideration.

b. Scope

Email request for Board determination as to whether Kipapa LLC is required to obtain a guard agency license pursuant to HRS chapter 463-7(b) if the Kipapa LLC traffic controllers are subject to the registration requirements under Act 208.

The Board reviewed the Kipapa LLC traffic control flagger work description and the definition of a "guard" in HRS chapter 463-1 as follows:

"Guard" means a registered uniformed or nonuniformed person responsible for the safekeeping of a client's properties and persons within contractually prescribed boundaries, and for observation and reporting relative to such safekeeping. "Guard" shall not include any active duty federal, state, or county law enforcement officers or personnel."

As flaggers do not appear to be "responsible for the safekeeping of a client's properties and persons within contractually prescribed boundaries...", it did not appear that these flaggers are subject to Act 208.

It was moved by Vice Chairperson Galas, seconded by Chief Perry and unanimously carried based solely on the Kipapa LLC traffic control flaggers work description and the definition of "guard" in HRS chapter 463-1, the Board determined that traffic control flaggers are not subject to the registration requirements of Act 208 and HRS chapter 463-1.
