Legislation: Airport Security

The Executive Officer informed the board of potential legislation that may be introduced that prohibits private detectives and guards from self-identifying as law enforcement officers by wearing or using a badge, uniform, vehicle or anything associated with a law enforcement officer employed by a government law enforcement organization.

Senator Rosalyn Baker wants it made clear that guards at airports should not wear uniforms, badges, or ride in patrol cars that state "airport police". Thus she is contemplating legislation to clearly prohibit guards from identifying as "police".

Mr. Denis informed the Board that the airports division must have law enforcement personnel according to Code of Federal Regulations 49 ("CFR") §1542.215 and 49 CFR §1542.217 authorizes arrest authority.

The Executive Officer noted that the current HRS §463-11 already prohibits any licensee from using any designation which implies any association with any municipal, county, state or territorial government or the federal government law enforcement agency. This section also precludes the use of any badge or uniform capable of being associated with a badge or uniform of any government law enforcement organization.

In addition, Mr. Tam discussed HRS §216-17 which clearly allows the Department of Transportation to confer its police powers (powers to serve notices, execute warrants and arrest offenders) to agents, and representatives to include persons performing services at the airports under contract with the Department of Transportation.

Based upon HRS §261-17 and the Board's prior determination at its April 11, 2013 meeting, the Board reaffirmed that the airport law enforcement officers "LEO's" are active law enforcement officers when they are on duty at the airports and while so employed are exempt from HRS §463.

Act 208 (SLH 2010)

Implementation:

a. Initial 8 Hour Security Guard Training Curricula

- 1) Classroom Definition (Deferred from the April 16, 2015 meeting.)

Mr. Denis volunteered to work on a definition of "classroom" instruction for the Board's consideration. It was moved by Chief Perry, seconded by Mr. Chang and unanimously carried to defer discussion on this matter.

b. Scope

- 1) Email inquiry regarding continuing education training self-certification.

The Board reviewed Mr. Hill's inquiry as to whether a guard instructor could self-certify for the continuing education curriculum he will be teaching. After some discussion it was moved by Mr. Chang, seconded by Mr. Denis and unanimously carried to defer decision on allowing a guard instructor to self-certify pending verification of the following:

- a) The approved 4 hour curriculum the guard instructor is authorized to instruct; and
- b) A list of guard employees taught by the applicant within the last 6 months verifying the following:
 - (i) Dates and times of classes held; and
 - (ii) Guard employee names and registration numbers.

Chief Kubojiri left the meeting at 1:08 p.m.

- 2) Email inquiry from G4S regarding acceptable proof of a high school education.

The Board reviewed Lee Burgwinkel's email regarding acceptable proof of a high school education for international college students attending Brigham Young University-Hawaii. After some discussion, based solely on the descriptions and information provided, it was moved by Chief Perry, seconded by Mr. Chang and unanimously carried that the Board would accept as proof of a high school education the transcripts BYUH used to admit the students.

- 3) Email inquiry from G4S as to whether escorts/ushers of camera teams during the Pro Bowl are subject to the registration requirements of Act 208 and whether "monitor people" posted 25 feet in front of entry gate are also subject to the registration requirements of Act 208 if they are advising game attendees of the NFL clear bag policy and informing them to empty their pockets and hold items in hand upon approaching the gate to expedite screening process.

After some discussion and based solely on the descriptions and information provided, it was moved by Mr. Chang, seconded by Mr. Denis and unanimously carried that the ESPN escort/ushers of camera teams do not need to be registered pursuant to Act 208 but the "monitor people" positions are subject to the requirements of Act 208 and do require registration as guard employees.
