Call to Order: There being a quorum present, the meeting was called to order at 10:56 a.m. by Chairperson Inouye.

Chapter 91, HRS  
Adjudicatory  
Matters:

Chairperson Inouye called for a recess from the Board's meeting at 11:14 a.m. to discuss and deliberate on the following adjudicatory matters pursuant to HRS Chapter 91.

Following discussion, it was moved by Mr. Denis, seconded by Chief Kubojiri, and unanimously carried to approve the settlement

agreements prior to filing of petition for disciplinary actions and Board's final orders for the above principal guard and guard agency licenses.

Following the Board's review, deliberation and discussion on these matters, pursuant to HRS Chapter 91, Chairperson Inouye announced that the Board was reconvening to its open meeting at 11:16 a.m.

Executive Officer's Report:

a. DCCA Disciplinary Actions (through January 2016)  
Distributed for information only.

b. Employee Registration Forms ("ERF")

The Executive Officer informed the Board that the ERF form has been changed. There are now two separate forms, Employee Registration Forms for:

1) Detective Agency/Firm/Sole

Basically the same form; however clearly requires detective entities to report no hires or terminations.

2) Guard Agency/Firm/Sole

This forms was revised to address Act 208 (SLH 2010) and the requirement that all guard employees hold a guard employee registration.

c. Guard Employee Registration Renewal

The Executive Officer informed the Board that Licensing will notify approved new applicants from April 1, through June 30, 2016 of their registration options up front to expedite the registration process during the renewal period.

Postcard registration renewal reminder notices will be sent out to all registered guard employees on May 6, 2016. Online renewal will be available from May 9, 2016 and will stop at midnight, June 30, 2016

HRS §463-10.5  
and Any Matters  
Relating to its  
Implementation:

a. Initial 8 Hour Security Guard Training Curricula

- 1) Classroom Definition (Deferred from the April 16, 2015 meeting.)

Mr. Denis submitted the following rule language for the definition of "Classroom" and other Information for the Boards consideration addressing enabling remote/distance learning:

**Definition of Classroom**

Any suitable facility or location that will provide a comfortable environment conducive to learning. Such locations will provide sufficient surface work space for GDE applicants to receive the HRS 463-10.5, Act 208 Board-approved initial eight (8) hour and/or four (4) hour CEU curricula and instructional content, testing and certification.

- A) Instruction and testing shall be provided live, by Board approved instructors, either in person, or at remote distance learning classrooms by simultaneous (synchronous) two-way interactive video conferencing feed; able to be viewed by all applicants; displayed on monitors sufficient in size to encourage all applicants present to participate.

- 1) Technology applications used for remote or distance learning must be capable of displaying instructional content including, but not limited to:
  - a. Live instructor; PowerPoint presentations; video and text and other content that may comprise each module of instruction.
  - b. Each remote or distance learning classroom as defined herein shall be staffed by an

employee of Agency or Third Party as a supervising proctor who will ensure:

- (i) That an orderly, safe learning environment is maintained.
- (ii) That all applicants have the opportunity to engage in dialogue and participate interactively with the primary Board approved instructor for Q&A and general student instructional needs.
- (iii) Ensure integrity of module testing and results by watching over applicant module examinations.
- (iv) Grade module exams, the results of which are to be scanned and emailed as attachments, faxed or otherwise transmitted to the Board approved instructor.
- (v) Be responsible for verification of GDE applicant identity and other information to include, but not limited to the following: (sign-in sheet with columns, **manual or electronic?**)
  - Board approved instructor name
  - Company or employer providing instruction
  - Date
  - Course instruction start, break and end times of day
  - Physical address of primary and remote classrooms
  - GDE applicant: last name, first name
  - Applicant's mailing address & email address
  - For CEU instruction, include applicant GDE number

- Collect and grade module test results, ensure additional interactive instruction to pass as intended
- At conclusion of eight-hour instruction: receive and distribute signed copies of Board approved form Certificates of Completion (originals to be mailed to applicants' address of record).

### **Technology**

Technology open items for discussion:

- Video conferencing (Go To Seminar or similar proprietary technology)
- Internet TV
- Skype
- Primary classroom equipped with audio/video to applicant computer terminal similarly equipped with audio video capabilities
- Instructor via camera and audio equipped CPU on internet, utilizing courseware to instruct applicant(s) interactive learning on CPU of similar configuration (utilizing like technology) to instruct Board-approved curricula and instructional content.

Module testing may be conducted utilizing:

- Hard copy paper and pencil; CPU's; electronic tablets or other mobile devices that transmit and receive audio & video, including exam fields with blank and completed answers to Board-approved instructor or subordinate proctor for grading and forwarding to Board-approved instructor.

The Executive Officer asked if there was generic language for this type of instructional method. Mr. Denis responded that he will get input from other curricula providers. Board members thanked Mr. Denis for his efforts in this endeavor. Chairperson Inouye asked members to review the language for discussion at the next meeting.

b. Scope

- 1) Email inquiry regarding continuing education training self-certification. (Deferred at the January 14, 2016 meeting.)

The Board reviewed Mr. Hill's documentation of the approved 4 hour curriculum he is authorized to instruct and the list of guard employees he has taught within the last 6 months verifying the dates and times of classes held; and the guard employee names and registration numbers. After some discussion it was moved by Mr. Chang, seconded by Mr. Denis and unanimously carried to allow Mr. Hill to self-certify that he met his guard registration continuing education renewal requirement.

- 2) Email inquiry regarding guard cards for police officers.

The Executive Officer informed the Board that HRS §463-1 does not include police officers. DAG Tam asked the Board to look at the definition of "License" in HRS §436B-2 in regards to an active duty police officer moonlighting as security:

"License" means the permission to engage in a profession or vocation granted by the applicable licensing authority to a person who has satisfied every requirement for licensure, and shall include any registration, certificate, or other document issued by the licensing authority reflecting proof of permission.'

In addition, DAG Tam asked members to look at HAR §16-97-8(b) Conflict of Interest.

"(b) An employee or a reserve officer of any law enforcement agency shall not maintain or be eligible for any license issued under chapter 463, HRS."

Chief Kubojiri informed the Board that Hawaii County has discontinued "moonlighting" due to liability issues and the concern that performing "like" duties may also result in Fair Labor Standards Act issues. Off duty police officers performing special duty must act as independent contractors and under LIOSA, police officers cannot carry concealed weapons when they are off duty.

After further discussion, it was the consensus of the Board to defer this matter for further research by DAG Tam and discussion with the Attorney General's office.
