After discussion, it was moved by Ms. Tokunaga, seconded by Mr. Nelson, and unanimously carried to approve the twenty-two (22) barber shop and beauty shop applications listed above.

Mr. Nelson stated he has nothing new to report and that his gathering of updated information on the examination and the exam administration is ongoing.

Chairperson Marugame asked Mr. Nelson about the passing rate for first-time barber candidates of the NIC barber licensing examination. Mr. Nelson recalled a drop in the passing rate during the initial transition from non-NIC examination to the NIC barber test and a steady rise thereafter in California, Texas, and Florida. Chairperson Marugame asked Mr. Nelson to obtain this data for all license categories.
