Old Business:

A. <u>National Board of Chiropractic Examiners Ethics and</u> Boundaries Examination.

At its July 3, 2014 meeting, the Board discussed the Ethics and Boundaries examination (E&B) as another tool for licensure, however, rules would need to be promulgated to incorporate E&B as an exam requirement.

Subsequently, after being informed of this, members of the Board requested DAG Jacob to report back to the Board on how it will affect Regulated Industries Complaint Office (RICO).

DAG Jacob commented that RICO is the prosecuting body and suggested that RICO may consider utilizing E&B in a contested hearing instance or a proposed order.

Discussion followed. Dr. Klein indicated that E&B is a valuable tool and would like to see E&B be utilized, whether it be approved by the Board or by RICO.

Dr. Pleiss indicated that E&B is already being utilized by other state boards. The Board expressed interest in how
