C. November 3, 2015 Email from Gary Saito, D.C. Re: Request for Clarification.

The Board reviewed and discussed the email dated November 3, 2015 from Gary Saito, D.C.

Dr. Saito's email asks "can a person who has <u>not</u> completed a doctoral program accredited by the CCE and who does <u>not</u> have a Doctor of Chiropractic degree from any institution of higher learning apply for and get a license to practice chiropractic in Hawaii?"

After due consideration, the Board informally opined that this person does not meet the educational requirement to practice chiropractic in Hawaii. The Board based its decision on Section 442-2, Hawaii Revised Statutes ("HRS").

Dr. Saito's email also asked for "clarification as to whether chiropractors licensed to practice in the State of Hawaii are doctors," and whether or not it is appropriate for a Chiropractor to use the word doctor.

After due consideration, the Board referred to HRS Section 442-19 which set forth the title for Chiropractor licensees.

In accordance with HAR section 16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision, and thus, is not to be viewed as binding on the Board.
