The Board reviewed and discussed Nicole Albano's email dated February 18, 2016, regarding purging of records.

After due consideration of Ms. Albano's email, it was moved by Dr. Pleiss, seconded by Ms. Kang-Kaulupali, and unanimously carried that the Hawaii Revised Statutes (HRS) Chapter 442 and Hawaii Administrative Rules (HAR) Chapter 76 do not specifically address purging of records.

Additionally, the Board noted that medical professionals (chiropractors) may be subject to other State and federal regulations addressing the purging of records that are beyond the scope of the Board's jurisdiction. As such, the Board's suggested that Ms. Albano contact the State of Hawaii Department of Health, State of Hawaii Office of Consumer Protection, and the United States Department of Health and Human Services for additional information. It

was also suggested that Ms. Albano consult an attorney for further advice and counsel.
