- b. <u>Matters Relating to the Central Regional Dental Testing</u>
 <u>Service ("CRDTS")</u>
 - Report on CRDTS Annual Meeting and Workshop

Ms. Matsushima and Ms. Primiano each provided a written report of their attendance at the CRDTS Annual Meeting and Workshop to the Board members.

Mr. Jacob reported one of the keynote speakers at the meeting was an attorney that had represented the North Carolina Board in the FTC vs. North Carolina Dental Board Supreme Course case. He gave about an hour long presentation on the history of the "Sherman Act" and some thought on were the FTC may be going in the future. To give you some background on the Sherman Act, it was passed in 1890 to prevent anti-competitive economic practices such as restraints on monopolies, or restraints on trade. Historically the Sherman Act has not been applicable to government because government has the ability to regulate.

There was a California Attorney General opinion that Mr. Kobashigawa sent to the Board that goes into this more in depth. Essentially there are three tiers that are subject to the Sherman Act. The top tier being your state government, your legislature, your governor, and your supreme court which has immunity from violations of the Sherman Act. The second tier classifications go to government agencies such as DCCA. Agencies can act through promulgation of rules and as long as the legislature has given a clearly articulated principal and it's explicit, any regulatory functions an agency may do will have immunity in the Sherman Act. Generally licensing Boards such as ours fall into the second tier, however in the North Carolina decision it was the first time that the Supreme Court has found a government agency to have violated the Sherman Act. The third tier was created as private parties on behalf of the state, and that's where the licensing boards are now thought to exist. The new thing was the act of supervision that's required. Essentially as a licensing board you cannot just go and do whatever you want unless there is some sort of active supervision from the government.

b. <u>FARB Top Regulatory Cases Newsletter</u>

Ms. Matsushima reported that the Alabama Supreme Court held that the provision in Alabama's dental practice act that defined teeth whitening as within the practice of dentistry did not violate plaintiffs' teeth whiteners' due process rights under the Alabama constitution. Because teeth whitening was in their practice act, the lower court granted summary judgement in favor of the board.

c. <u>Dental Assisting National Board Publications</u>

Ms. Matsushima stated she can provide the publications if anyone wants to review them.

9. Public Comment:

Mr. Liebling stated he was recently in attendance at various meetings on the mainland and it turns out that several states that no longer do direct examinations have gone about changing their names from the Board of "Dental Examiners" to the Board of Dentistry.

Chair Guevara stated he has heard about that but it would require a statutory change.

Mr. Liebling stated he just wanted to share that information. Otherwise he thinks the Board is doing a great job and to feel free to let him help the Board with any communication.

Vice Chair Wada asked Mr. Liebling how the Ethics continuing education course is coming along.

Mr. Liebling stated they are going to be putting together the course and putting it online so it is no hassle and try to add it in as a member benefit for HDA members and at a moderate cost for non HDA members. So it will be available to everyone. Another thing that is somewhat related to this is they would also like to see a jurisprudence piece to this, it is very important for dentists to review jurisprudence every two years because of changes and additions.

Vice Chair Wada stated that is a great idea.

Dr. Rebmann asked Mr. Liebling if there will be an in classroom ethics course or only online.

Mr. Liebling stated it will be only online.

Mr. Wilhite stated the American College of Dentistry will have a course that you can attend in person.

Dr. Rebmann stated he is a member of the California Dental Association and one of their requirements every two years is infection control and California dental law. Those classes by far are the most popular classes that people attend.

Mr. Liebling stated they could put on a jurisprudence class and include infection control, they want this to be as good as possible.
