Per DAG Tam and Mr. Morinaga, you only need elevator mechanics if you penetrate the interior cab shell or diversely affect the operation or safety of the elevator, as cited in HAR §16-81-4. If you do not penetrate the cab shell you do not need a license pursuant to HAR §16-81-4 (1) (2) and (3).
