1. Call to Order: There being a quorum present, the Chairperson called the meeting to order at

9:09 a.m.

3. Approval of Minutes Upon a motion by the Vice-Chairperson, seconded by Ms. Bath, it was voted on and unanimously carried to approve the minutes of the October 29, 2014 meeting as circulated.

4. Chair's Report:

The Chairperson had no issues to report.

5. Vice Chair's Report: The Vice-Chairperson had no issues to report.

6. Executive Officer's Report: Regarding Prometric's request to update the content of the Hawaii massage therapy examination, the EO reported that he had received a list of reference materials currently used to teach massage students from some of the Hawaii licensed massage schools. He noted that at the last meeting, the Chairperson had asked him to find out if Prometric had updated the exam after a similar review in 2010. He was told that as a result of the 2010 review, the exam was updated in 2011, however, due to a high pass rate, Prometric is requesting that the exam content be reviewed again.

The Chairperson asked what the pass rate is.

The EO said 67%.

The Board asked the EO to find out why Prometric believes 67% to be a high pass rate and if there are other factors involved in requesting the review.

The EO reported that the 2015 legislative session recently started. There is already one bill, H.B. No. 787, pertaining to massage. He reminded the Board that hearing notices can be posted as late as twenty-four (24) hours prior to the hearing and they will need to designate a member to represent them at legislative hearings.

This matter was deferred to the end of the meeting.

Executive Session:

At 9:16 a.m., it was moved by Ms. Bath, seconded by the Vice-Chairperson, and unanimously carried to move into Executive Session in accordance with HRS section 92-5(a)(4) "[t]o consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both;" and "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities".

At 9:45 a.m., it was moved by the Vice-Chairperson, seconded by Ms. Bath, and unanimously carried to move out of executive session.

7. New Business:

a. Questions about agenda items and testimony from public

The DAG gave a brief summary of Ms. Bath's e-mail inquiry in which she asked if the items on the agenda may be limited and whether comments from the public during the meeting may be limited or submitted only in writing or given as testimony.

The Chairperson stated that the Board's annual meeting schedule is posted on its website and the meeting agenda is posted on the State calendar website at least six (6) calendar days before the meeting date. The meeting is open to the public. Anyone can submit a written request to include an item on the agenda or submit written comments on an item on the agenda. Oral testimony can also be given at the meeting.

8. <u>Unfinished</u> Business:

b. Complaint from Gerald Lam regarding Lomilomi; Response from the Regulated Industries Complaints Office ("RICO"); Gerald Lam's Response to RICO

The DAG gave a brief summary of Mr. Lam's letter regarding the practice of lomilomi under HRS chapter 452.

The Chairperson noted that the definition of "massage" in HRS chapter 452 only covers the physical practice, not any spiritual aspects, of massage therapy. HRS chapter 452 clearly includes "Hawaiian massage" and "lomilomi" within the scope of practice of massage therapists.

Mr. Mason said he feels that lomi is its own modality that involves spiritual, mental and emotional aspects and also includes and integration of hula and lua. He questioned why the Board cannot provide oversight and enforcement. He stated that he has seen many miracles and other significant events happen due to the energy of the islands. He feels the term "lomilomi" has been exploited and should not be used by someone just because they took a 3-5 day workshop.

According to his letter, Mr. Lam considers lomilomi to be more of a spiritual practice than a physical practice and asserts the following:

- Licensed Massage Therapists ("LMTs") advertising and practicing lomilomi commonly violate the massage licensing law;
- 2. LMTs advertising and practicing lomilomi are misrepresenting themselves and defrauding consumers;
- 3. LMTs practicing lomilomi must be medically licensed, or certified as statutorily exempt from medical licensing;
- Licensing massage therapists for lomilomi is unconstitutional and violates the fundamental rights of traditional Native Hawaiian healing practitioners;
- LMTs advertising and practicing lomilomi that lack Hawaiian ancestry are in violation of state laws;
- 6. LMTs advertising and practicing lomilomi violate cultural ethics and social propriety exposing themselves and conspirators to tort liability.

The Council is requesting that LMTs be immediately ordered and directed to cease all advertisements, representations and practice of "Hawaiian massage commonly known as lomilomi" and that the public be promptly notified that licensed massage therapists are prohibited from practicing the Native Hawaiian traditional practice of lomilomi, and that such spiritual practice is not subject to authorization and regulation by the Board of Massage Therapy.

The DAG noted that when the Board discussed Mr. Lam's letter at their last meeting, the Board members commented that they can only respond based on what is in their statutes and rules. The definition of "massage" does not address any spiritual aspect, only the physical practice, of massage therapy. The bottom line is that with regards to the physical practice of massage, lomilomi is a type of massage modality. He asked Mr. Mason to describe what the physical definition of "lomilomi" is to him.

Mr. Mason stated that he believes that lomilomi is 80% spiritual and 20% physical. The physical aspect involves manipulation of muscle, tissue and bone; however, there is a descriptive point to every sequence that is based on genealogical ties.

The Chairperson noted that the statues and rules are very broad and cover as many modalities as possible. While the Board respects the Hawaiian community, the statutes and rules do not address a massage therapist's use of prayer, meditation, chants, music, and other types of external enhancements to a physical massage. Thus, the Board believes that matters beyond the physical performance of massage (including the use of external enhancements) are outside the Board's jurisdiction. Consequently, the Board does not believe

that the use of external enhancements by a licensed massage therapist violates any of the provisions of HRS chapter 452.

Mr. Mason noted that true lomilomi is a dying art. Kupunas are dying so the art is dying with them. He questioned why the law is vague.

The DAG stated that the law is established by the Legislature and the Legislature included "Hawaiian massage" and "lomilomi" within the scope of practice of massage therapists and made the definition broad. He noted that the purpose of the Board is to ensure public protection and that licensees meet the minimum qualifications required. The Board can only implement the law as it is. He asked if anyone else in the audience wanted to describe what they consider to be the physical aspect of lomilomi.

Ms. McKeon stated that she is a licensed massage therapist and also a cultural practitioner of lomilomi. She took intense training in lomilomi at Hale Makua. She feels the public perception of lomilomi is that it involves longer strokes and biomechanical waves.

Ms. Pardini said from a public standpoint, she feels that providers should be certified. She cited an example of someone claiming to be a Rolfing teacher without proper training.

Ms. McKeon commented that every ahupua'a had its own practitioner. Each practitioner was taught a different way. The techniques were handed down from generation to generation.

Based on the comments from the public and Board members, the physical practice of lomilomi is similar to a Swedish type of massage (i.e., the strokes are similar).

The Chairperson stated that the Board can only govern what is in its statutes and rules, and does not allow them to make any determinations based on intent. Each individual's intent may be different depending on their training, lineage and so forth. The Board cannot govern that.

The DAG thanked the audience for their input. He reiterated that the Board can only respond based on what is in their laws and rules, therefore, they are bound by the definition in the law. The spiritual aspect of the modality is not covered, so that is beyond the Board's jurisdiction. He also stated that the Board's laws and rules do not limit the practice of massage based on race or ancestry and thus, do not discriminate against any licensee.

By consensus, the Board asked the EO to draft a response to Mr. Lam that expressed the above in more detail.

The Board agreed that their response is an informal interpretation for informational and explanatory purposes only and is not an official opinion or decision.

9. Applications: a. Ratifications

Upon a motion by Ms. Bath, seconded by the Vice-Chairperson, it was voted on and unanimously carried to approve the attached ratification list.
