1. <u>Call to Order</u>: There being a quorum present, the Chair called the meeting to order at 9:07 a.m.

3. <u>Approval of Minutes</u> Upon a motion by Vice Chair Davis, seconded by Ms. Behnken, it was voted on of the January 28, and unanimously carried to approve the minutes of the January 28, 2015 meeting

2015 Meeting: as circulated.

4. New Business: a. Senate Concurrent Resolution ("SCR") 46, SD 2

Ms. Tamanaha introduced herself and gave a brief summary of SCR 46, SD 2, which requests that the Department of Education ("DOE") and Department of Commerce and Consumer Affairs ("DCCA") convene a working group to evaluate the licensing of private trade, vocational, and technical schools.

Ms. Tamanaha and Mr. Mikell asked the board members questions pertaining to regional, national and federal accreditation of massage schools.

Ms. Behnken stated that while she currently works for a DOE licensed massage school, the school is not federally accredited.

Chair Nagashima said that her college currently has DOE and national licensing and is currently looking at the possibility of becoming regionally accredited.

The Board inquired about the composition of the working group.

Ms. Tamanaha said that at this time, they are currently in the beginning stages of working on this project. She is not sure what the makeup of the working group will be. Right now, they are just meeting with the boards which may be affected by this resolution.

b. Letter regarding Board's Response to Gerald Lam

DAG Tam gave a brief summary of Mr. Lam's previous inquiry regarding the practice of lomilomi under HRS Chapter 452 as well as a summary of the letter from Lahela Hekehia, Esq. regarding the Board's response to Mr. Lam's inquiry.

After some discussion, it was the consensus of the Board to direct EO Keen to inform Ms. Hekehia that the Board has taken her comments under advisement.

c. <u>List of Textbooks and References used by Hawaii Massage Schools</u> provided to Prometric

EO Keen reported that per Prometric's request, he had submitted to them a list of textbooks and references used by Hawaii Massage Schools based on the responses he received from the schools.

d. Hawaii News Now Article regarding illegal activity at massage parlors

EO Keen gave a brief summary of the article regarding illegal activity at massage parlors.

DAG Tam reminded the Board that they do not have purview over unlicensed activity. Any complaints received which involve unlicensed activity are handled by the Regulated Industries Complaints Office ("RICO").

Vice Chair Davis expressed concern that articles such as this one are making the public perception of legitimate professionals worse. He asked the reporter could be contacted to do a piece on legitimate professionals.

EO Keen said that the Board could not make such a suggestion and if any of the Board members do so, they cannot identify themselves as Board members, only as an industry professional.

Vice Chair Davis asked Ms. Fritz if AMTA Hawaii would consider possibly doing something to encourage a more positive perception of massage therapists as professionals.

Ms. Fritz said she would look into doing so.

Chair Nagashima reminded everyone that the public should be encouraged to report any complaints to RICO. RICO can only investigate if someone files a complaint.
