## 3. Approval of Minutes of the

October 28, 2015 Meeting: Upon a motion by Ms. Bath, seconded by Ms. Behnken, it was voted on and unanimously carried to approve the minutes of the October 28, 2015 meeting as circulated.

## 4. Executive Officer's Report:

#### a. 2016 Legislative Representative

EO Keen reminded the Board that at their last meeting, they decided that for the 2016 legislative session, Chair Nagashima will be the Board's official representative and Vice Chair Davis and Ms. Behnken will be alternates.

#### b. 2016 Legislation

#### 1) <u>SCR 46</u>

EO Keen noted that at their July 1, 2015 meeting, Supervising Executive Officer Charlene Tamanaha and Administrative Assistant Sean Mikell gave a brief summary of SCR 46 which requested that the Department of Education ("DOE") and Department of Commerce and Consumer Affairs ("DCCA") convene a working group to evaluate the licensing of private trade, vocational, and technical schools. The group's report as well as the draft bill relating to this matter was distributed in the board packets. He reported that since the packets were mailed, the draft bill has been introduced as Senate Bill No. 2976. The companion bill is House Bill No. 2454. He informed the Board that the Department of Commerce and Consumer Affairs ("DCCA") will be submitting testimony opposing these bills.

EO Keen reminded the Board that they already have the ability to approve schools pursuant to HRS §452-13(a)(3) which states in part "An applicant for examination shall have completed academic training...as a massage therapist apprentice or massage therapist student in a school approved by the board...". (emphasis added)

Chair Nagashima informed the board members that any comments or suggestions for language adding school approval requirements to the Board's rules should be submitted to EO Keen.

Ms. Bath and Ms. Behnken expressed concern that the board members do not have the knowledge or training to properly review a school's credentials.

Chair Nagashima asked if the Board had to submit testimony on the bills.

EO Keen stated he did not think so as the DCCA has already submitted testimony but he would double check.

After some discussion, it was the consensus of the Board to monitor the bills.

#### 2) HB 787

EO Keen gave a brief summary of HB 787 which establishes acts that are prohibited of any person who practices massage for compensation.

After some discussion, it was the consensus of the Board to support this bill.

#### 3) HB 1390

EO Keen gave a brief summary of HB 1390 which establishes licensure requirements for certified massage therapists and massage therapist assistants, eliminates massage apprentices, amends certain provisions relating to the Board of Massage Therapy and amends certain provisions relating to the licensure, certification, and registration for the practice of massage.

Chair Nagashima noted that the bill adds an additional certification for a Hawaii licensed massage therapist ("MAT") to become a "certified massage therapist" and would allow the certified massage therapist to perform a massage that "includes the assessment and treatment of humans to evaluate, prevent, and alleviate pain, anguish, and other physical and mental diseases and disorders primarily by means of massage therapy. It includes consultation, evaluation, treatment, and modification of treatment."

Ms. Behnken questioned whether this new certification was necessary.

Vice Chair Davis noted that massage therapists are not allowed to assess and treat clients.

Chair Nagashima expressed doubt that massage therapists have the training to assess and treat for mental diseases and disorders. She noted that the bill would have massage therapists crossing over into disciplines they are not trained for.

Ms. Estrella noted that AMTA Hawaii representatives had met with Matthew Pardini of the Hawaii Massage Association, a major proponent of the bill, last year. She stated that AMTA Hawaii agrees that the bill moves

into treatments not covered by the massage therapy scope of practice. Her understanding is that one of the purposes of the bill was to change the definitions to allow for more latitude for massage therapists to obtain more medical referrals which would allow more insurance claims. Mr. Pardini was also concerned that massage apprentices don't necessarily get the same level of education as massage school students.

Chair Nagashima noted that the Board has no purview over insurance issues. She also commented that massage therapy is an adjunct care profession and massage therapists should not be providing any medical diagnosis.

Vice Chair Davis questioned the elimination of the massage apprentices while adding massage therapist assistants.

Upon a motion by Ms. Bath, seconded by Vice Chair Davis, it was voted on and unanimously carried to oppose HB 1390.

#### 4) HB 1071, HD 1

EO Keen gave a brief summary of HB 1071, HD 1 which amends or repeals various provisions of the Hawaii Revised Statutes and the Session Laws of Hawaii for the purposes of correcting errors and references, clarifying language, and deleting obsolete or unnecessary provisions.

After some discussion, it was the consensus of the Board to take no position on this bill.

#### 5) SB 2863/HB 2334

EO Keen gave a brief summary of SB 2863/HB 2334 which authorizes the issuance of a citation for specific violations of massage therapy laws by licensees, sets forth a process for licensees to contest the citation and provides for the assessment of fines for each violation. He noted that these bills are the proposed legislation by RICO that was discussed at their October 28, 2015 meeting. The Board agreed to support the intent of the proposed legislation. The first hearing on SB 2863 is being held this morning and based on their motion at the last meeting, the Board submitted testimony in favor of the bill.

After some discussion, it was the consensus of the Board to support these bills.

#### 6) <u>SB 264</u>

EO Keen gave a brief summary of SB 264 which prohibits advertisements for massage, relaxation, spa, escort, or body rubs from including images depicting any person being advertised as a massage therapist, relaxation therapist, or escort in a nude condition. He noted that the bill was provided for information only as there are no proposed amendments or changes to the Board's statutes.

DAG Tam noted that this bill amends the penal code.

#### 7) HB 2233

EO Keen gave a brief summary of HB 2233 which requires health care professionals to take an annual continuing medical education ("CME") course in health issues unique to Hawaii and requires the Department of Health ("DOH") to develop the course, in consultation with the Hawaii Medical Board ("HMB"). The companion bill is Senate Bill No. 3041. He informed the Board that the DCCA will be submitting testimony opposing these bills.

Ms. Bath said she feels that these bills are important and the Board should support them. She guestioned why the DCCA would oppose the bills.

Chair Nagashima noted the DCCA's testimony states the following reasons for opposing the bill:

- The requirement of annual CME would be overly burdensome on the DCCA if it were not tied to the licensee's renewal.
- The requirement of annual CME, in addition to already established CME requirements for most health care professionals, would cause an undue burden on the licensees and boards/programs.
- With regard to setting content standards for CME requirements, the DCCA feels that health care professionals should obtain CME within their specialty or area of focus. As such, they prefer to give health care professionals the latitude to determine what those CME would be. Requiring content-specific CME would also be burdensome, especially in light of the fact that the proposed CME would be in addition to the CME required by the health care professionals' boards.

- The measure mandates that the DOH develop and update the course content of CME in consultation with the HMB. The measure fails to provide for input from the other health care related professions addressed in HRS Chapter 451D. Furthermore, the measure also fails to address the potential that the DOH and Hawaii Medical Board may not have recommendations or changes. If this is the case, licensees could potentially take the same course each year which would not benefit the licensee nor the consuming public in anyway.
- The proposed language seems to imply that the board/program shall offer the course to its licensees and may also determine the mode of its delivery. It is totally out of the jurisdiction of the regulatory boards/programs to be in the business of providing CME courses. Boards/programs may approve other organizations to provide the CME, but in no instance has any board/program provided or delivered the CME course.
- This measure fails to provide a delayed implementation date so that the DCCA, relevant regulatory boards/programs, and licensees can prepare for such an undertaking.

Chair Nagashima said she thinks the DCCA's testimony includes some valid concerns.

Ms. Bath stated she feels it is in the public interest for health care professionals, including massage therapists, to take such a course. She suggested a dialog with the DCCA to discuss the issue.

Chair Nagashima noted that if the Board wants to add a continuing education requirement, they will need to propose language for a bill to amend their law. She asked if there were any board members who would like to volunteer to work on proposed language.

Ms. Bath volunteered and agreed to report back to the Board on her progress at the next meeting.

After some discussion, it was the consensus of the Board to support the intent of these bills.

#### c. Hawaii Massage Exam

EO Keen reported that he received an email from the Hawaii Prometric Office asking that the Board confirm if they would like to keep the exam content with the current percentages.

Chair Nagashima noted that she previously compared the Hawaii Massage Exam content percentages to those of other exams like the Massage and Bodywork Licensing Examination ("MBLEx") and found the percentages similar.

## 5. <u>Unfinished</u> Business:

#### a. Rule Revisions - Title 16, Chapter 84, Hawaii Administrative Rules ("HAR")

EO Keen noted that new comments were provided by Ms. Behnken. The subcommittee has also provided a revised subchapter 1 which incorporates both Ms. Bath's comments as well as the comments submitted by Ms. Behnken at the last meeting.

Vice Chair Davis reported that the subcommittee is working on making revisions to the current draft by incorporating the comments from Ms. Bath and Ms. Behnken. Once the committee finishes a revised subchapter of the draft, it will be submitted for the Board to review.

Chair Nagashima noted that if Ms. Bath and Ms. Behnken have additional comments or concerns they should submit them to EO Keen who will forward them to the subcommittee.

Ms. Bath expressed concern with the definition of "direct supervision", noting that massage therapists may be less inclined to sponsor apprentices if they have to leave their own client to assist their apprentice. She feels this would be of more concern on the neighbor islands where it is already difficult to find willing sponsors.

Vice Chair Davis noted that the Board has to trust that a massage therapist who accepts the responsibility to be a sponsor does so knowing exactly what that entails.

Chair Nagashima stated that the rules must be written in a way that is enforceable by RICO.

Ms. Bath suggested that each massage establishment have a chart which is visible to clients that lists both the massage apprentices and their sponsors working that day.

Vice Chair Davis questioned how that would make the individuals involved accountable.

Ms. Bath stated that if the sponsor is listed on the chart and they are not available, RICO can cite them. She noted that she has been thinking about the issue of accountability for a while.

Vice Chair Davis suggested that Ms. Bath propose language which establishes the level of accountability she would like.

Ms. Bath agreed.

DAG Tam noted that other boards with similar apprentice permits have supervision requirements that vary between "general" and "direct" supervision. General supervision means the sponsor is accessible by phone but is not necessarily in the building. Direct supervision means the sponsor is physically present in the room.

6. New Business: None.

#### 7. Applications: a. Ratifications

Upon a motion by Ms. Behnken, seconded by Vice Chair Davis, it was voted on and unanimously carried to approve the attached ratification list.

Chair Nagashima noted that the Board would be going into Executive Session to discuss applications. She asked the audience if they had any comments or concerns for the Board before they go into Executive Session.

Mr. Sato questioned how a massage therapist who is nationally certified and licensed in another state applies for a Hawaii license and is told they do not meet the education requirements.

DAG Tam noted that all applicants must meet Hawaii's education requirements, regardless of other certifications or licenses in other jurisdictions.

Mr. Sato asked whether experience could be counted towards the education requirement.

Chair Nagashima noted that work experience is not credited towards the education requirement.

Recess: At 11:04 a.m., Chair Nagashima called for a recess.

Reconvene: At 11:10 a.m., the Board returned to its regular order of business.

#### Melanie Rose

Upon a motion by Ms. Behnken, seconded by Vice Chair Davis, it was voted on and unanimously carried to deny Ms. Rose's request for exam waiver on the basis of §452-16, HRS.

#### Sara Waugh

Upon a motion by Vice Chair Davis, seconded by Ms. Behnken, it was voted on and unanimously carried to defer Ms. Waugh's application pending review of her application and if she meets the education requirements, to delegate to the EO to approve Ms. Waugh to sit for the exam.

#### Naomi Boggs

Upon a motion by Ms. Behnken, seconded by Ms. Bath, it was voted on and unanimously carried to deny Ms. Boggs' request for exam waiver on the basis of §452-16, HRS.

#### Susan Hoo

Upon a motion by Ms. Behnken, seconded by Ms. Bath, it was voted on and unanimously carried to approve Ms. Hoo's application for massage therapist apprentice registration.
