EXECUTIVE SESSION

At 9:55 a.m., it was moved by Mr. Short, seconded by Mr. Touchi, and unanimously carried to return to the Board's regular order of business.

Applications – Temporary Licenses

Board members reviewed the applications and documents submitted. The above temporary licenses were issued in error. The applicants failed to complete certain portions of the applications, make payment or sign the application forms. Even though written requests for the information were mailed to the applicants, via their employing MVD, neither the applicant nor the MVD replied to the requests. Upon a motion by Mr. Touchi, seconded by Mr. Johnsen, it was voted on and unanimously carried to direct the Executive Officer to write to the applicant, copy to the MVD, and instruct the applicant to provide the information needed to complete their applications within fourteen (14) days or their temporary licenses will be terminated on the fourteenth day. The Executive Officer was directed to report back to the Board on the status.

Motor Vehicle Salesperson

Azbill, David W., Jr.

After discussion, it was moved by Mr. Touchi, seconded by Mr. Short, and unanimously carried to approve the application for a salesperson's license for Mr. Azbill.

Motor Vehicle Dealer

A-Z Bus Sales Inc.

Matt Essex, salesperson for the company, stated that he was authorized to speak on the company's behalf. He stated that they are relocating the dealership and the application has been delayed due to a misunderstanding about the agreement A-Z has for the line make Blue Bird. He explained the ownership of Blue Bird and the relationship with Gerardin, which resulted in the creation of Microbird. He added that A-Z has a written agreement with Blue Bird but not with Microbird. They are applying to sell Microbird on the basis of the Blue Bird agreement. He is hoping that the Board will accept the Blue Bird agreement in light of the explanation he has provided.

Board members agreed by consensus that without the written agreement with Blue Bird, the application to sell Blue Bird cannot be approved.

Mr. Essex stated that since all other portions of their application are complete, they will withdraw their request to sell Blue Bird until they submit the written agreement.

It was moved by Mr. Short, seconded by Mr. Touchi and unanimously carried to approve the application of A-Z Bus Sales, Inc. without the authorization to sell Blue Bird line make.

Ohana Automotive Group, Inc.

After discussion, it was moved by Mr. Short, seconded by Mr. Touchi and unanimously carried to approve the application for Ohana Automotive Group, Inc.

New Business

Jeff Crabtree

It was noted that Mr. Crabtree was not in the audience. Mr. Short stated that since the law was changed, it appears that the tide has turned. Whereas before the law changed, many dealers were not complying with the title transfer requirement and now, it appears that most dealers are complying and a few dealers are not complying. After discussion, the members agreed by consensus that the matter be monitored and that consumers file their complaints with RICO for enforcement purposes.
