<u>Call to Order</u>: There being a quorum present, the meeting was called to order by

Chairperson Gibson at 2:05 p.m.

Election of Officers: The floor was opened for nominations for the office of Chairperson.

Ms. Ng nominated Dr. Gibson as Chairperson. The nomination was seconded by Dr. Taketa-Wong. There were no other nominations

for Chairperson. Dr. Gibson was elected Chairperson by

acclamation.

The floor was opened for nominations for the office of Vice Chairperson. Dr. Gibson nominated Dr. Chun as Vice Chairperson. The nomination was seconded by Ms. Ng. There were no other nominations for Vice Chairperson. Dr. Chun was elected Vice Chairperson by acclamation.

Additions and Revisions to the Agenda:

It was moved by Ms. Ng, seconded by Dr. Taketa-Wong, and unanimously carried to delete agenda item 5.b. Prescriptive Authority/training requirements from the agenda.

Approval of the May 9, 2014
Meeting Minutes:

It was moved by Ms. Ng, seconded by Dr. Taketa-Wong, and unanimously carried to approve the May 9, 2014 Meeting Minutes as circulated.

New Business:

a. <u>Intrauterine Devices</u>

The Board received an inquiry regarding whether naturopathic physicians are permitted to prescribe intrauterine devices ("IUDs"). The Board reviewed Hawaii Revised Statutes ("HRS") chapter 455 including the definition of "naturopathic medicine" in HRS section 455-1 which in part states:

"The practice of naturopathic medicine includes the prescription, administration, dispensing, and use of nutrition and food science, physical modalities, manual manipulation, parental therapy, minor office procedures, naturopathic formulary, hygiene and immunization, contraceptive devices, common diagnostic procedures, and behavioral medicine of the type taught in education and training at naturopathic medical colleges;..."

Chairperson Gibson indicated that naturopathic physicians receive standard training in the subject of obstetrics and gynecology.

After discussion, it was the Board's consensus and informal opinion that prescribing contraceptive devices falls within the above definition of "naturopathic medicine".

Legislation:

a. <u>Senate Bill No. 2577, S.D. 2, H.D. 2, C.D. 1 Relating to</u> Naturopathic Physicians

Executive Officer Cabral informed members that this measure was signed into law by Neil Abercrombie, Governor, State of Hawaii, as Act 222 effective July 7, 2014.

This Act requires naturopathic physicians in the state of Hawaii to complete a minimum of thirty-five credit hours of continuing education, including a minimum of fifteen hours in pharmacology, beginning with the December 31, 2017 renewal, and prior to every biennial renewal thereafter.

Members discussed professional associations and organizations that would be acceptable to satisfy the continuing education requirements.

The Board felt that courses approved by the American Association of Naturopathic Physicians; the American Medical Association; and the American Osteopathic Association may satisfy the continuing education requirements for renewal. It will further discuss this matter at a future board meeting.

a. Denisa Hrncirik-Maruyama

On September 28, 2012 Dr. Hrncirik-Maruyama was issued a conditional license as she agreed to abide by the conditions placed upon her conditional license: her license is only valid until September 1, 2014 unless she provides evidence that the U.S. government has extended her authorization to work in the U.S.

Members reviewed and discussed documentation submitted by Dr. Hrncirik-Maruyama.

After discussion, the Board came to a consensus that Dr. Hrncirik-Maruyama has abided by the conditions placed on her license, therefore, her license expires on December 31, 2015.

d. Qualifying Course on Parenteral Therapy

• IV Nutritional Therapy for Physicians "Fundamentals and Clinical Applications of IV Nutrient Therapy" course offered in Seattle, Washington on September 5-8, 2013.

This course was deferred at the Board's August 9, 2013 meeting pending receipt of documentation that Dr. Raithel meets the requirements of HAR section 16-88-57(d)(1) and receipt of an attestation that this course is the same as one that was previously approved by the Board.

Members reviewed and discussed materials submitted by Dr. Osborne.

After discussion, the Board came to a consensus that the IV Nutritional Therapy for Physicians "Fundamentals and Clinical Applications of IV Nutrient Therapy" course being offered in Seattle, Washington on September 5-8, 2013 is equivalent in content to course Index Number 12-001, which was approved on January 18, 2012.

After discussion, the Board came to a consensus that the IV Nutritional Therapy for Physicians "Fundamentals and Clinical Applications of IV Nutrient Therapy" course being offered in Seattle, Washington on September 5-8, 2014 is equivalent in content to course Index Number 11-001, which was approved on March 29, 2011.
