Approval of the February 11, 2015 Meeting Minutes:

It was moved by Ms. Ng, seconded by Dr. Taketa-Wong, and unanimously carried to approve the February 11, 2015 Meeting Minutes as circulated.

Old Business: a. Natural childbirth

At its February 11, 2015 board meeting, while members informally believed that natural childbirth is within their scope of practice, they felt that legislative amendments would clarify this position.

Dr. Taketa-Wong indicated that proposed amendments to Hawaii Administrative Rules should specify additional training in natural childbirth.

Dr. Gibson indicated that the board does not have the expertise to establish the minimum requirements for licensed naturopathic physicians to practice natural childbirth.

Dr. Taketa-Wong would inquire with the Hawaii Society of Naturopathic Physicians as to its definition of natural childbirth.

Dr. Gibson suggested that the Board review the American Association of Naturopathic Physicians and other state board's definition of natural childbirth.

This matter will be discussed at a later meeting.

New Business:

a. <u>Proposed amendments to Hawaii Administrative Rules</u> <u>Chapter 88</u>

A draft of the proposed administrative rules on Continuing Education was distributed to members for their review and comments.

A new subchapter is being added to implement Act 222, Section 2014 ("Act 222"). Act 222 requires the Board to adopt administrative rules that requires naturopathic physicians to complete a minimum of thirty-five hours of continuing education courses, including a minimum of fifteen hours of pharmacology, during each licensing biennium commencing January 1, 2016 – December 31, 2017.

It was moved by Ms. Ng, seconded by Dr. Taketa-Wong, and unanimously carried to approve the draft proposed rules on continuing education.
