<u>Agenda</u> :	The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").
1. Call to Order:	There being a quorum present, Chair Reynolds called the meeting to order at 8:33 a.m.
2. <u>Additions/</u> <u>Revisions to</u> <u>Agenda</u> :	None.
3. <u>Approval of</u> Board Meeting	Chair Reynolds asked if there were any questions or comments on the minutes.
<u>Minutes</u> of March 30, 2015:	After some discussion, upon a motion by Vice Chair Saito, seconded by Dr. Shoji, it was voted on and unanimously carried to approve the minutes of the March 30, 2015 meeting as circulated.

4. <u>Executive</u> <u>Officer's</u> <u>Report:</u> EO Matsushima noted that the deadline for board members to submit their report to the Ethics Commission was June 1<sup>st</sup>.

EO Matsushima reported that Chair Reynolds, Dr. Loo and Ms. Chang have been reappointed to the Board. She noted that Dr. Seulyn Au will begin her term as a licensee member effective July 1st.

EO Matsushima announced that this is Dr. Lui's last meeting as a Board member. She thanked Dr. Lui for devoting valuable time while serving on the Board.

EO Matsushima stated that the Board may consider appointing an advisory committee to conduct research on issues as assigned by the Board. The advisory committee could then report their findings to the Board. She noted that several issues have come up recently such as dispensing medication, mobile exam units and continuing education reporting requirements in which having an advisory committee may be helpful to the Board. The members of an advisory committee do not have to be current members of the Board.

DAG Jacob noted that if the Board decides to form an advisory committee, they will need to ensure that the amount of members meets the Sunshine Law requirements.

EO Matsushima said that if the Board decides to form an advisory committee, the meetings would be as needed and could be held prior to the regular Board meeting. Any recommendations by an advisory committee would be presented to the Board at a regular Board meeting for discussion. Any action on the information presented by an advisory committee would take place at the following Board meeting. She noted that an advisory committee would not make any decisions, they would just conduct research as directed by the Board and provide their recommendations. Any action taken would be by the Board at a regularly scheduled Board meeting.

Dr. Lui asked if minutes would be kept at any advisory committee meeting.

EO Matsushima said yes.

Ms. Chang said she feels there is no downside to forming an advisory committee as the advisory committee would only meet as needed.

Dr. Shoji asked what would trigger an advisory committee meeting.

EO Matsushima said the Board would determine when an advisory committee meeting is needed.

Chair Reynolds asked if there were any volunteers.

Dr. Shoji, Dr. Loo and Dr. Lui expressed interest in being on an advisory committee.

Chair Reynolds suggested Dr. Jon Ishihara, a former Board Chair.

After some discussion, upon a motion by Ms. Chang, seconded by Dr. Lui, it was voted on and unanimously carried to form an advisory committee consisting of Dr. Shoji, Dr. Loo and Dr. Lui with Dr. Jon Ishihara as the alternate.

Chair Reynolds inquired whether the composition of the advisory committee would give the impression that the committee is self-serving as it is comprised solely of past and present Board members. He said he does not want the public to have a negative perception of the advisory committee.

Dr. Lui reiterated that the advisory committee would be assigned to research topics by the Board. The advisory committee would present their research to the Board and provide their recommendations. Any decisions on those topics would be made solely by the Board at a Board meeting.

Dr. Shoji noted that any advisory committee meetings would require that an agenda be filed and minutes of the meetings would be taken. The meetings would also be open to the public.

EO Matsushima reminded the Board that they will decide when the advisory committee needs to meet. If an advisory committee meeting is scheduled, the start time of the Board meeting will be later.
