Call to Order: There being a quorum present, the meeting was called to order by Chairperson Hashimoto at 1:30 p.m.

Approval of the Meeting Minutes: It was moved by Ms. Chun Fat, seconded by Mr. Oliphant, and unanimously carried to approve the minutes of the October 31, 2014 meeting as circulated.

Dr. Shanahan indicated that her application may be reviewed in open session.

Dr. Combs briefed the Board on Dr. Shanahan's application and noted that Dr. Shanahan received her doctoral degree from Argosy University Hawaii (APA accredited in clinical psychology). It was further noted that Dr. Shanahan completed her internship experience at the Waianae Coast Comprehensive Health Center, in one year and accumulated 2,091 hours.

Furthermore, Dr. Shanahan completed her postdoctoral experience under the direct supervision of Donna G. Goodwin, Psy.D., in one year and accumulated 1,941 hours.

Dr. Combs went on to say that Dr. Shanahan passed the EPPP exam on April 23, 2014, with a score of 630 (Hawaii's passing score at the time was 500).
