# a. <u>House Bill No. 1072, H.D. 1 Relating to Prescriptive Authority for</u> Certain Psychologists

Dr. Nowak shared with the board that H.B. 1072, H.D. 1 will likely be reintroduced in its current form during the next legislative session. She indicated that members should review the proposed draft testimony and bill in preparation for the next legislative session.
