Mr. Santiago clarified with members that HPA wants to be open and cooperative with the Board. He expressed his concerns over the level of detail in the Board's August 28, 2015 open meeting minutes, indicating that legislative matters are very sensitive.

DAG Molay stated that the Board meeting minutes must disclose an accurate account of the meeting.

Mr. Oliphant indicated that the Board must conduct its meetings as governed by the Sunshine Law. DAG Molay supported this by indicating that in accordance with Hawaii Revised Statutes Chapter

92-9, the written minutes shall give a true reflection of the matters discussed at the meeting and the views of the participants.

DAG Molay advised members that they may either accept or not accept the August 28, 2015 meeting minutes as written. He further explained that if the Board does not accept the minutes as written, then it may vote on changes to the minutes.

Mr. Santiago stated that the August 28, 2015 minutes should have reflected that there was an understanding that the legislators would consider resurrecting the current measure in the committee or introduce a new bill.

He indicated that it was his understanding that Speaker Souki continues to be supportive of prescriptive authority.

Members discussed the following amendments to the Board's testimony should a bill be introduced in the 2016 legislative session:
