The Executive Officer informed the Board that she is currently converting the rule revisions to Ramseyer format.

The Executive Officer asked the Board if they had additional changes to the rules and suggested that the rules should include that "the RME shall be in residence" in HAR 16-94-25 should be made more clear that the company can continue to complete contracts already signed and executed by the previous RME but the pest control business cannot solicit new business without an RME. Chairperson Yates asked if the 30-day period will stay in the rules. The Executive Officer responded that the 30-day period is in the statute and the Board is therefore bound to this language.
