There being no amendments, upon a motion by Mr. Joslyn, seconded by Ms. Tali, it was voted on and unanimously carried to approve the minutes of the December 5, 2013 meeting as circulated.

The EO reported Dr. Fleming and Ms. Tali will be attending the NCSBN 2014 Midyear Meeting in Kansas City, Missouri.

#### 2014 Legislature

HB 2052/SB 2227 – Relating to Provider Orders for Life-Sustaining Treatment
The EO reported these bills increase access to POLST by updating references from
"physician orders for life-sustaining treatment" to "provider orders for life-sustaining
treatment" throughout chapter 327K, HRS; expanding health care provider signatory
authority to include advanced practice registered nurses; and correcting inconsistencies
over terms used to describe who may sign a POLST form on behalf of a patient.

The EO reported HB 2052 was passed un-amended by the House Health Committee and referred to the Consumer Protection Committee. SB 2227 was heard by the Senate Health Committee and passed un-amended as well.

Upon a motion by the Vice Chair, seconded by Dr. Cohen it was voted on and unanimously carried to support HB 2052 and SB 2227.

#### HB 2317/SB 2867 – Relating to Physician Orders for Life-Sustaining Treatment

The EO reported these bills expand signature authorization to include advanced practice registered nurses. Makes technical corrections to the Hawaii physician orders for life-sustaining treatments law.

Both bills have not been scheduled for hearing.

Upon a motion by the Dr. Cohen, seconded by Mr. Joslyn it was voted on and unanimously carried to support HB 2317 and SB 2867.

#### HB 2095/SB 2491 - Relating to Nursing

The EO reported these bills replace references to advanced practice registered nurse recognition with advanced practice registered nurse licensure to align Hawaii's law with national standards.

Both bills have not been scheduled for hearing

Upon a motion by Dr. Cohen, seconded by Ms. Tali it was voted on and unanimously carried to support HB 2095 and SB 2491.

#### HB 2099/SB 2492 - Relating to Advanced Practice Registered Nurses

The EO reported these bills amend various sections of the Hawaii Revised Statutes to enable advanced practice registered nurses to practice to the fullest extent of their training and education.

SB 2492 was heard by the Senate Health Committee and passed with technical non-substantial changes. HB 2099 has not been scheduled for hearing.

Upon a motion by the Vice Chair, seconded by Dr. Cohen it was voted on and unanimously carried to support HB 2099 and SB 2492

## HB 1698 – Relating to Nurses

The EO reported this bill provides that the scope of practice for advanced practice registered nurses includes certain oral health treatment.

No hearing has been scheduled for this bill. No companion bill.

The Vice Chair stated she supports the need and intent, however the bill is unnecessary.

The Chair stated her concern is when you have legislation that so specifically delineates the actions that are allowed, do you have to go back and look at everything.

The DAG stated with the proper training and education it is the Boards understanding that a nurse can already do this.

The EO stated just because there is a Dental Board in Hawaii and they have jurisdiction over your mouth, teeth, etc., it does not mean other professionals don't overlap in that area. Your practice act is not specific. If you receive the appropriate education and

training, work under the supervision of a physician, dentist, etc., or are carrying out the orders of a physician, dentist, etc., it may come under your practice act.

The Chair stated this bill is not necessary to allow APRNs to provide this service.

Upon a motion by the Vice Chair, seconded by Mr. Joslyn it was voted on and unanimously carried to state the bill is not necessary because current regulations already support an APRNs practice based on the proper training and education.

## HB 2411/SB2469 - Relating to Telehealth

The EO reported these bills require reimbursement for services provided through telehealth to be equivalent to reimbursement for the same services provided via face-to-face contact between a health care provider and a patient. Clarifies that a health care provider of telehealth includes primary care providers, mental health providers, and oral health providers such as physicians and osteopathic physicians, advanced practice registered nurses, psychologists, and dentists. Amends references to "telemedicine" in the Hawaii Revised Statutes to "telehealth" for consistency.

HB 2411 was heard by the House Health Committee, they deferred decision making to February 12, 2014. SB 2469 was heard by the Senate Health and Technology Committee. Their decision making is deferred to February 10, 2014.

The Vice Chair stated reimbursement is not something the Board normally gets involved in when it comes to regulating practice and public safety.

The Board does not have a position on these bills. The EO stated she will continue to monitor them and report to the Board.

#### SB 2569 Relating to Home Birth

The EO reported this bill establishes the home birth safety board to adopt rules and protocols for home birth providers. Requires home birth providers to be licensed beginning on 7/1/2015 and to meet minimum educational and training requirements. Requires the home birth safety board to investigate complaints concerning violations of its regulations and to take disciplinary action when necessary. Limits home births to clients with normal, low risk pregnancies. Requires licensed home, birth providers to use informed consent documents with their clients and to follow record keeping and reporting requirements.

No hearing has been scheduled for this bill.

Guest Mauren Shannon addressed the Board regarding this bill. Dr. Shannon stated this bill is a result of neo-natal deaths that have been brought to the hospitals by naturopaths not certified nurse midwives or midwives under licensure. Another issue was wanting to regulate people who do home births and track them because not everyone with a bad outcome comes to the hospital. One concern Dr. Shannon expressed was the over regulation of nurse midwives as they already come under the Board of Nursing. The other concern is that the bill starts to erode the nurse practice act. Dr. Shannon is requesting the Boards opposition to this bill.

The Chair stated her opinion is the Board is neutral on the bill but does not accept people who are already covered by the Board of Nursing be required to be included. Certified nurse midwives should be exempt.

Mr. Joslyn stated in the last paragraph of the bill it refers to informed consent documents, Mr. Joslyn asked Dr. Shannon if their group does these types of documents.

Dr. Shannon stated yes, it is automatic; they all sign a consent document.

Mr. Joslyn asked if the consent document is updated as the pregnancy continues.

Dr. Shannon stated yes, they are updated as the pregnancy continues and there are several visits.

The EO stated if the Board is going to say that certified nurse midwives should not be included in this bill because they are already regulated in 16-89-81, HAR, are these things covered in the American College of Nurse-Midwives scope of practice.

The Vice Chair stated the wording in 16-89-81, HAR was taken word for word from the American College of Nurse-Midwives statement of their scope of practice.

Upon a motion by the Vice Chair, seconded by Mr. Hoban it was voted on and unanimously carried to oppose the inclusion of certified nurse midwives in language of the bill.

#### HB 2096/SB 2490 – Relating to Continuing Competency for Nurses

The EO reported these bills require license registered and licensed practical nurses to submit evidence of continuing competency at each renewal period, beginning with the June 20, 2015, licensing biennium.

HB 2096 has not been scheduled for hearing. SB 2490 was heard by the Senate Health Committee, it was passed with technical amendments.

The EO stated it is not clear where the nurses are going to do the self assessment.

The Chair stated there is no way to regulate the self assessment. The bill does not delineate what needs to be included in the assessment, who is going to determine it and who is going to assess whether the determination is accurate.

Ms. Elvenia stated the organization that she is employed by provides a lot of opportunities to complete CE's; however, the self assessment requirement would be impossible to regulate. If the requirement alone was to complete 30 hours of CE's, that would not be a problem even if your employer does not provide CE's. There are other ways of doing CE's for example online CE's.

Mr. Joslyn stated although he applauds the attempt to come to competency as a guide to how well a nurse is doing, there is no way of implementing this.

The DAG stated you could say you support this in concept however let's have a working committee or a resolution.

The Chair stated the reality is an employer is required to evaluate competency.

Mr. Hoban stated continuing education is not necessarily going online, continuing education can be training on new equipment, where someone comes in and trains your staff, or it can be listening to a lecture; there are a lot of different ways to gain CE's.

The Chair stated she does not believe the issue is with completing CE's, what the Hawaii State Center for Nursing (HSCFN) is saying is that CE's are not sufficient for a nurse to maintain competence. However to have a regulation that requires a nurse to do a self assessment, you can't monitor or evaluate that.

Mr. Joslyn stated although he agrees with Mr. Hoban statement regarding the different ways to gain CE's, somewhere along the line, someone has approved those for CE's.

The EO clarified the Boards concern is the self assessment and how it would be implemented. Who would monitor and/or evaluate the self assessment.

The Chair stated yes.

The Board deferred further discussion.

#### HB 1753/SB 2061 Relating to Continuing Education

The EO reported these bills, beginning with the renewal for the licensing biennium commencing on July 1, 2015, requires nurses to complete a minimum of thirty hours of continuing education during each two-year license period.

No hearing has been scheduled for both bills.

Upon a motion by Dr. Cohen, seconded by Mr. Joslyn it was voted on and unanimously carried to support HB 1753 and SB 2061.

#### SB 3044 – Relating to Criminal History Record Check for Nurses

The EO reported this bill requires applicants for licensure under chapter 457, Hawaii Revised Statutes, to submit fingerprints for criminal history record checks as a condition of licensure.

No hearing has been scheduled for this bill.

Upon a motion by Dr. Cohen, seconded by the Chair it was voted on with Mr. Hoban, Ms. Tali and Ms. Elvenia voting to support SB 3044, and the Vice Chair and Mr. Joslyn abstaining. The motion carries.

#### HB 2503 – Relating to Sexual Assaults

The EO reported this bill limits acts of penetration to any authorized or valid medical procedures by licensed practitioners within the scope of their practice. Includes medical and osteopathic physicians and surgeons, naturopaths, physical therapists, assistants, nurses and midwives as licensed practitioners.

No hearing has been scheduled for this bill.

The Board does not have a position on this bill. The EO stated she will monitor the bill and report to the Board.

#### HB 1881/SB 2489 – Relating to the Center for Nursing

The EO reported these bills amend the composition of the center for nursing advisory board by decreasing the number of members on the center for nursing advisory board to nine; specifying the membership of the advisory board to better facilitate the center for nursing's mission; and clarifying term limits and appointment to the advisory board. Amends certain powers and duties of the advisory board.

HB 1881 was heard by the House Higher Education Committee and was passed without amendments. SB 2489 has not been heard.

Upon a motion by the Chair, seconded by Dr. Cohen it was voted on and unanimously carried to support the Center changing the number of board members and thank the Center for considering a position for a Board of Nursing ("BON") member. However the BON does not think it is necessary to have a position on the Center's advisory board due to their collaborative relationship and encourage the Center to consider neighbor island members.

Dr. Cohen stated she would like to add <u>SB 2055 – Relating to Narcotic Drugs</u> to the agenda. This bill amends prescriptive authority for narcotic drugs listed in schedule III of the controlled substance act by: requiring a written prescription from a practitioner; limiting the prescriptions to a thirty day supply with no refill; and limiting who may prescribe these drugs.

The EO stated this bill has been deferred, and since this bill would not amend chapter 457 and the other bills do, she only tracks these bills and reports on them to the Board.

The Chair stated she attended the hearing when SB 2055 was heard, and most of the testimony was not in support.

Offer from Daria Loy-Goto, Complaints and Enforcement Officer, Regulated Industries Complaints Office (RICO), To Attend Board Meeting to Discuss Any Questions

The EO reported Ms. Loy-Goto from RICO is offering to meet with the Board to address any concerns and/or questions the Board may have. The EO asked the Board to provide any questions or concerns they may want to address to Ms. Loy-Goto first, and she will relay them to Ms. Loy-Goto.

## **Expedited Partner Therapy Prescriptions**

The EO reported this law passed in 2013. APRNs with prescriptive authority can write a prescription for a partner of a patient who they have examined and determined has an STD. A pharmacist will fill a prescription written for Expedited Partner Therapy (EPT), a name is not required. In this new law APRNs are considered healthcare providers; therefore if you do write an EPT prescription, you are required to provide information sheets from the Department of Health (DOH). The information is available on the Board of Nursing's webpage under Important Announcements or on the DOH's webpage.
