The Chair called for a motion in regards to the minutes of the February 6, 2014 meeting.

The Vice Chair stated she would like more attention made to quoting in the minutes, for example, when someone asks a question, it should say in the minutes: Mr. Joslyn "asked", instead of Mr. Joslyn" stated".

There being no further comments or corrections, upon a motion by Mr. Joslyn, seconded by Ms. Tali, it was voted on and unanimously carried to approve the minutes of the February 6, 2014 meeting as circulated.

Guest Dan Purcell asked regarding agenda item #1 Public Notice, what does that mean?

The DAG replied, it means that public notice has been given, the agenda has been filed at the lieutenant governor's office and been posted on the State's calendar.

Mr. Purcell asked at what point on the agenda are public comments going to be heard?

The DAG replied there is no agenda item for public comments.

Mr. Purcell stated this is a public meeting; you have to receive public comments at some point. He stated he knows he is speaking to the Deputy Attorney General and therefore he does not need to tell her this.

The DAG stated she knows she is speaking with Mr. Dan Purcell, and should he have a comment related to any item on the agenda, you may raise your hand. If the Chair chooses to recognize you, she may invite you to speak.

Mr. Purcell stated he has an opportunity for public comments no matter what.

The DAG replied to Mr. Purcell that he may make that statement, but it is up to the Chair to run the meeting smoothly and efficiently.

Mr. Purcell stated he can contact the Office of Information Practices and have that corrected if he needs to and have an action taken to say that the meeting is not being run properly. I don't think the Chair wants that.

The DAG stated, yes you may, and I don't think you want to be disruptive either.

Mr. Purcell stated the Chair understands there is an opportunity for public comment.

The EO asked Mr. Purcell if there is anything on the agenda that he would like to comment on.

Mr. Purcell stated yes he does have something to comment on. He recently attended a Board of Pharmacy meeting, where the Executive Officer is the same person. He addressed the Board stating that some of you may recall he was at the September 5, 2013 Board of Nursing meeting and Diane Corn, RICO attorney spoke at that meeting. He stated in his opinion Ms. Corn was scolding the Board about Hawaii being first in the nation in under-reporting of clinical thefts, specifically over prescribing and theft of hydrocodone.

## 2014 Legislature

The EO reported on the following bills.

<u>HB 2052/SB 2227 – Relating to Provider Orders for Life-Sustaining Treatment</u> Both bills are still alive and have been transmitted to the House and Senate crossover respectively.

<u>HB 2317/SB 2867 – Relating to Physician Orders for Life-Sustaining Treatment</u> Both bills are dead.

#### HB 2095/SB 2491 – Relating to Nursing

HB 2095 is dead; however SB 2491 is alive and was transmitted to the House and may be heard tomorrow.

# HB 2099/SB 2492 - Relating to Advanced Practice Registered Nurses

Both bills are still alive and have been transmitted to the House and Senate crossover respectively.

# HB 1698 – Relating to Nurses

This bill is dead.

## HB 2411/SB2469 – Relating to Telehealth

HB 2411 is dead; however SB 2469 is alive and was transmitted to the House.

### SB 2569 Relating to Home Birth

This bill is dead.

HB 2096/SB 2490 – Relating to Continuing Competency for Nurses HB 2096 is dead; however SB 2490 was transmitted to the House.

Guest Mary Boland was present and addressed the Board on SB 2490.

Ms. Boland stated in terms of SB 2490, Senator Baker submitted this in response to the work done by the Hawaii State Center for Nursing ("Center"). There was a Senate Resolution about three years ago to convene a task force to look at continuing education. Although this legislation is moving forward, at the hearing last week, there was some concern on the part of the Board of Nursing. Ms. Boland asked the Board if there were any areas that were particular difficult, or if they had any questions.

The Chair stated one of the Board's concerns was the speed at which they would be able to implement all the components of the competency evaluation. The nursing workforce needs to be introduced to the competency of self assessment and creating a learning plan, and that would not be something that they would be ready to do at the next renewal.

Ms. Boland stated that is true and the intent of the legislation is that the program would become effective in 2015, but nurses would then have two years to be informed and work to begin to do the activity in 2017. Ms. Boland stated the question from her perspective is if you make it effective 2017, then it doesn't begin until 2019, and do we really want to wait that long given that we are one of seven states in the nation that does not mandate continued competency and the only profession in the Hawaii that doesn't mandate.

The DAG asked Ms. Boland to clarify what she meant by the only profession in Hawaii that doesn't mandate?

Ms. Boland stated in terms of the health professions, the Board of Nursing doesn't mandate CE's.

The DAG stated she does not believe the Board of Nursing is the last profession to require CE's.

Ms. Boland stated the DAG is correct.

The Vice Chair asked Ms. Boland, in regards to Hawaii being one of seven states that don't mandate continued competency, how many of the states require a competency model versus just continuing education?

Ms. Boland stated she does not have that information at this time. However, the work that was done by the task force looked at that and consulted with the National Council State Boards of Nursing (NCSBN) and what they were hearing is that the movement is towards continuing competency.

Dr. Cohen stated the Board is having a hard time seeing how the self assessment model would work and have concerns with any funding that may be needed in order to implement this model.

Ms. Boland stated they recognize that, and that was the reason for getting legislation through but having time to plan for that. There are various different ways you could do it. The Center is currently in the final stages of an MOU with the DCCA for data sharing. That could potentially be a role for the Center to manage the assessment component.

The Chair stated in the bill, it allows for APRNs to substitute their national certification for this process and asked if she would you consider the same for RNs and LPNs who achieve national certification?

Ms. Boland stated certainly, that should be acceptable. If you are doing it nationally you don't want to have to repeat it at the state level. We can put an amendment that says any nurse who is nationally certified in an area could substitute.

The Vice Chair stated this bill is putting into law what should be in regulation and that she understands there has been great success in moving things forward quickly going the legislature route. But she is very concerned about the level of detail and how prescriptive the bill is for the average staff nurse, and that they may not have the academic inclination for this. She asked Ms. Boland what has been the outcome of Carolina's bills? And was there any evaluation. pre-implementation, and any post-implementation evaluation that shows any difference in quality of care or nurse safety issues?

Ms. Boland stated they have had conference calls with them and they shared what they had done and they are looking at evaluations and they are very concerned about the impact. At the same time they recognize there is a responsibility to assure the public that nurses have not just graduated and never attended anything further. Ms. Boland stated they also vetted this with nurses. They traveled to the neighbor islands and talked to the bargaining units and people were uniformly positive about it.

The Vice Chair stated another concern is about self evaluation as North Carolina's is structured. There is some evidence in the literature that shows the very people that you would most want to protect the public from, are the ones who are the most likely to think very highly of their own performance and asked Ms. Boland if they would consider something like what ANCC is doing using a specialty focused assessment and everybody takes the same assessment and you get an education plan of what you need to do based on that, so everyone is on the same ground rather than leaving it to self assessment?

Ms. Boland stated she appreciates that and thinks the concerns are significant. It is important to recognize we had a Senate Resolution that asked us to do this. It came in response to a bill from the employers. This is the nursing profession coming together to move forward on this. At some level we need to be making a decision.

The Chair stated theoretically the Board is in favor of a competency program. The concern, as the Vice Chair stated, is on the level of detail in the bill. If we could work to streamline some of it so that the concepts are not lost, but the details are allowed to be written into regulation rather than the bill, the Board would prefer that.

The EO stated in Senate Draft 2, Senator Baker inserted a stakeholder group to address any outstanding issues associated with the implementation of the continuing competency requirements and shall report to the legislature. The EO stated she is not sure how the Board feels about convening another task force. The EO suggested the Board look at the details of the bill and see what aspects of it you want to consolidate or try to put into rules so that this program can be implemented by the effective date.

The DAG asked Ms. Boland if she knows how much North Carolina budgets for their self assessment component?

Ms. Boland stated she does not have that information with her.

The DAG asked Ms. Boland if the Center is prepared to do a proportionate budget request next session for that component?

Ms. Boland stated that it is part of why the Board of Nursing was involved in this committee from the beginning because we knew those kinds of questions would come up, but we are not asking for additional funding. She stated that what we do know is a very small percentage of the re-licensing fees are overseen by the Board and that is a continuing concern. Staffing, although the EO does a great job, is also inadequate in terms of the numbers of nurses.

The Chair stated the one thing that she thinks is missing is some level of mandatory reporting, self reporting, or employer reporting of any practice issues in the workplace.

Ms. Boland stated she agrees that is a very important issue. However she sees it as separate, perhaps needing its own bill.

Mr. Joslyn stated back to the funding part of this, he does not know how this can be done in an audit situation without asking for funding. We can't expect the EO to do it; she would be doing nothing else.

The Chair stated she believes the expectation is you would require an attestation from the licensee and that would be sufficient, and the audit would be at will.

The DAG asked if there is language in the bill that specifies the Center will handle the assessment component?

Ms. Boland stated the Center is willing to work with the Board on it, but there is nothing in the legislation that says that.

The DAG stated in respect to the self assessment piece, that is an area of concern as to how this Board would manage it, even with the Center's assistance.

The Chair asked Ms. Boland if the Center would be supportive of the Board removing some of the detail from the bill?

The Center would be happy to look at that.

The Chair thanked Ms. Boland for her comments and time.

Further discussion was deferred.

## **Executive Officer Forum, Licensure Models**

The Board received a copy of the minutes from the last two Executive Officer Forums.

Dr. Cohen stated this is about looking at licensure recognition for all states and that she spoke with Kathy Apple, Executive Director of NCSBN and she stated the increase in interest of a national licensing model is not just in nursing but in all healthcare fields. In 1997 NCSBN started this process which is how the current "compact" license came about. However they are trying to figure out why some states have not joined as a compact state.

Dr. Cohen also stated that Ms. Apple said what is driving this is telehealth and telecommunication. Verizon is going to put \$17 billion dollars into telehealth in the next three years and basically what they are looking at is a national license.

# **APRN Scope of Practice Question**

Conduct Testing and Physical Examination of Body Systems to Determine if Driver is Physically Qualified to Drive a CMV in Interstate Commerce and Complete the Medical Examiner's Certificate

The Board reviewed an email inquiry asking if APRNs are permitted to conduct physical examinations. The specific question with the Board's response is as follows:

Does the scope of practice for APRNs permit them to conduct the testing and physical examination of body systems required on the "Medical Examination Report", determine whether the driver is physically qualified to drive a CMV in interstate commerce, and complete the "Medical Examiner's Certificate"?

Response:

It was the consensus of the Board that Hawaii licensed APRNs may conduct the testing and physical examination. This is an informal interpretation based solely on the information provided and is for informational and explanatory purposes only and is not

an official opinion or decision and therefore is not to be viewed as binding on the Board.

<u>APRN – Family Nurse Practitioner Administering Botox and Filler for "Cosmetic" Purposes</u> The Board reviewed an email inquiry asking if it is legal for an FNP who received training, to do Botox and Filler injections independently without MD collaboration?

Response:

It was the consensus of the Board to refer to Hawaii Revised Statutes §457-2.7 that states in part, "The scope of an advanced practice registered nurse includes but is not limited to advanced assessment and the diagnosis, prescription, selection, and administration of therapeutic measures including over the counter drugs, legend drugs, and controlled substances within the advanced practice registered nurse's role and specialty appropriate education and certification.

It was also recommended that the NCSBN Model Act and the following sections also be referred to: Hawaii Administrative Rules (HAR) §16-89-59, §16-89-60 and §HAR 16-89-81.
