Hawaii Nursing Programs:	2013 Hawaii Nursing Pass Rates/National Pass Rates
	Approval of Pass Rate Memo
	The Committee approved the Pass Rate Memo and recommended it be posted on the Board's web page.
	Review of Hawaii Nursing Programs' Pass Rate
	Dr. Cohen stated currently the national pass rate for 2013 is 83.04%.
	The EO asked if any school whose pass rate is under 83.04 percent for the RN program will be put on probation?
	Dr. Cohen stated any school under 74.7% should be on probation.
	Dr. Fleming stated those schools are already on a corrective action track, so we had said previously that they did not have to report quarterly because the corrective action may take a while.
	The EO asked if we should just wait for the annual reports?
	Dr. Fleming stated yes.
	Dr. Cohen stated we should but we should also send a letter to the schools saying that they are below the pass rate and we expect and extensive plan.
	Dr. Fleming stated we can tell them that the latest results indicate that you have not achieved 90% of the pass rate which is 74.7% and that if you have submitted a recent plan we would expect results based on that plan. If your plan was submitted more than a year ago, look at the plan and make the appropriate revisions.
