2014 Legislature – Status Report

The EO reported on the following bills.

HB 2052 – Relating to Provider Orders for Life-Sustaining Treatment

HB 2052 received notice of final reading by the House and is still alive.

SB 2491 – Relating to Nursing

SB 2491 was signed into law April 23, 2014, Act 46.

HB 2099/SB 2492 – Relating to Advanced Practice Registered Nurses
SB 2492 was signed into law April 23, 2014, Act 45.

HB 2099 died.

SB2469 – Relating to Telehealth
SB 2469 received notice of final reading by the House and is still alive.

SB 2490 – Relating to Continuing Competency for Nurses
SB 2490 died.

HB 1881 – Relating to the Center for Nursing
HB 1881 was sent to the Governor on April 14, 2014 and is expected to be signed into law.

Blue Special Parking Permits not valid after December 31, 2014

The EO deferred to the Secretary who reported that the blue permits that were issued to members will no longer be valid after December 31, 2014 and must be returned. A temporary half day parking permit will be sent to member's needing parking before each meeting in their packet.

Scope of Practice Question – Nurses Receiving Prescription Drugs

The Board reviewed an email inquiry about shipping vaccines to nurses, who have the training and knowledge to administer vaccines. The nurses would be working under the standing orders of the Medical Director, a Hawaii licensed physician, and there would be procedures in place to maintain vaccine integrity.

It is the consensus of the Board that this is outside the nurses' scope of practice. The vaccines must be shipped to the clinic.

Article, “More States Removing Barriers to Nursing Practice and Care

The Board was provided with a copy of an article from AARP about how more states are removing barriers to nursing practice and care. Hawaii is mentioned in the article.
