There being a quorum present, the Chair called the meeting to order at 9:00 a.m.

The Chair asked the Board members and audience to introduce themselves.

### **Approval of the Previous Minutes – April 17, 2014**

The Chair called for a motion in regards to the minutes of the April 17, 2014 meeting.

Upon a motion by Ms. Keefe, seconded by Ms. Kumasaka, it was voted on and unanimously carried to approve the minutes for the April 17, 2014 meeting as circulated.

#### Laws and Rules Committee Report:

The Chair reported on the Committee's April 17, 2014 meeting.

At its last meeting the Committee received resources and guides from the pharmacy students at the Daniel K. Inouye, College of Pharmacy University of Hawaii. The Committee will be reviewing the information provided and discussing at the next meeting. The EO will also be asking the students to provide copies of statutory regulatory citations from other states for the Committee to use as examples.

#### Executive Officer's Report:

### **Report on CE Audit for 2012 – 2013 Biennium**

The EO reported as of May 6, 2014, out of 107 audited pharmacists, approximately 20 have not responded yet. The deadline to respond is May 23, 2014.

### **Blue Special Parking Permits not valid after December 31, 2014**

The EO deferred to the Secretary who reported that the blue permits that were issued to members will no longer be valid after December 31, 2014 and must be returned. A temporary half day parking permit will be sent to member's needing parking before each meeting in their packet.

### **National Association of Boards of Pharmacy (NABP) – Seeking Volunteers for 2014-2015 Committees and Task Forces**

The National Association of Boards of Pharmacy (NABP) is seeking volunteers from its active member boards of pharmacy to serve on the 2014-2015 committees and task forces. Executive officers and board members interested in serving on a committee or task force are encouraged to submit a letter of interest and a current resume or curriculum vitae. In addition, NABP encourages interested board staff to volunteer for NABP task forces.

### **Transdermal Compounding Questions**

The Board reviewed an email inquiry asking four questions regarding transdermal compounding cream in the state of Hawaii. The questions and board responses are as follows:

1. How does Hawaii laws differ from other state regarding compounding transdermal creams? ***Hawaii pharmacy laws and rules do not have specific requirements for compounding.***
2. Are there any specific laws around compounding in Hawaii? ***See response to question #1***
3. Any limitations? ***See response to question #1.***
4. Any limitations with compounds that have schedule three drugs? For example Ketamine. ***Hawaii Revised Statutes Chapter 329, the Uniform Controlled Substances Act falls under the jurisdiction of the Department of Public Safety, Narcotics Enforcement Division.***

### **Compounding for Office Use – Out-of-State Pharmacies**

The Board reviewed correspondence regarding compounding for office use.

Guest Judy Ung from the Honolulu Pharmacy was present and clarified the correspondence. Ms.Ung stated right now doctors who use office injection medicine mostly receive it from the mainland even though it can be made locally. Being made locally it would save the patient and doctor money (time and shipping cost) and also money spent will be within the state of Hawaii and will help with the local economy.

Ms. Okamura stated if a local pharmacy wanted to compound for office use wouldn't they just need to obtain a wholesale distributors license?

The EO stated that was what the Board had previously determined.

The Chair stated the Drug Quality and Security Act of 2013, under section 503A it talks about prescriptions that pharmacies are allowed to compound. There is also section 503B which refers to outsource facilities that the FDA will be licensing. Under 503B there is a draft being created

that allows the state to enter into an MOU with the FDA and the MOU will allow the licensed pharmacy to ship products out-of-state. This is still being worked on but in time will be clarified.

The EO asked where in the pharmacy laws and rules it regulates manufacturers.

Dr. Ma stated it doesn't.

The EO asked Mr. Edwards if Chapter 328 has any requirements for manufacturers.

Mr. Edwards stated that although in the definition of manufacturing in Chapter 328 includes the act of compounding; it still has to be pursuant to a prescription.

After further discussion the Board deferred this matter.

### **Preprinted Prescription Pads, Keith Chamber, NuMedCare**

The Board reviewed an email inquiry asking three questions regarding preprinted prescription pads. The questions are as follows:

1. Can a prescription pad supplier pre-print multiple formulas on a prescription pad, giving doctors an option to simply check the formula they wish to prescribe, if the pad contains only non-controlled substances?
2. Would the first answer change if one or more of the formulas had a controlled substance in it? If so, what are the requirements for a controlled substance being pre-printed on a prescription pad?
3. Can there be more than one filled prescription per prescription pad (such as a prescription for pain cream and scar cream)?

After brief discussion the Board determined that they need clarification on what is meant by "formulas" in order to respond accurately.

The EO reported that the DAG has reviewed the draft and some minor non-substantive changes will be made.
