Correspondence

Report of the State Medical Board’s Model Policy for the Appropriate Use of Telemedicine Technologies in the Practice of Medicine

The Board was provided with a copy of a report of the State Medical Board’s model policy for the appropriate use of telemedicine technologies in the practice of medicine.

LPNs Working with Central Lines

The Board reviewed an email inquiry asking two questions. The questions with the Board’s responses are as follows:

1. Are LPNs allowed to work with Central lines if educated by an RN within our facility who has shown competency in working with Central lines?
2. Are there any specific skills that LPNs are UNABLE to perform as mandate by any rules/regulations set forth by the Board?

After some discussion and review of the nursing laws and rules, it was the Board’s informal interpretation that working with central lines may be beyond the scope of practice for an LPN as this is not necessarily a basic task as there may be a need for assessment. Also, there is no list of skills that an LPN can or cannot perform.

APRNs Performing Minor Surgical Procedures

The Board reviewed an email inquiry asking if doing minor surgical procedures (spinal injections, closed treatment of fractures, etc...) is in the scope of a nurse practitioners license in the State of Hawaii.

After some discussion and review of the nursing laws and rules, it was the Board’s informal interpretation that performing certain procedures depends on the education and training of the individual and that the Board does not endorse any specific procedures.

LPN Scope of Practice

The Board reviewed an email inquiry asking for clarification on what LPNs can and cannot do.

After some discussion and review of the nursing laws and rules, it was the Board’s informal interpretation that LPN’s may not assess or delegate, however, there is no list of skills that an LPN can or cannot perform.
