#### Foreign Educated Applicants – Credentials Review Required?

The Committee discussed if all applicants for a Hawaii nurse license must submit a CGFNS report, including those applicants who apply by endorsement/reciprocity. Upon review of HAR §16-89-8(c), all foreign educated applicants require a credentials review. Consequently, the Committee is recommending that the application process ensures that all foreign educated applicants submit a CGFNS report that indicates that the applicant's education is equal to or exceeds Hawaii's education requirement.
