Old Business: Collaborative Agreement

The Chair asked for guidance from the Committee members as to what they would like to see in the rules under this section and specifically for immunizations. Per the last discussion the Committee agreed to have a general statement as to what collaborative agreements are and include immunizations specifically. Not to make it highly defined or so restrictive, but to address a lot of the concerns where we currently have no rules surrounding immunizations. We need to clarify the statutory language but make sure that it is not totally restrictive and at the same time ensuring public safety.

Mr. Lau clarified the emergency contraception section will remain as is.

The Chair stated yes.

Ms. Okamura asked if immunizations can be included in the collaborative agreement section.

The Chair stated immunizations are a little different and should be defined separately. Under immunizations we need to not have it limited to immunizations. It needs to include administration of other medications such as in the event of adverse reaction to the immunization.

The Chair stated he will have the criteria broken down for the Committee at their next meeting.

Ms. Okamura provided the Committee with a copy of NABPs Model Act as it pertains to what should be included in a collaborative agreement as a reference.
